Stated Reasons

The Citizen Father is a Successful Immigrant with Limited Management Capacity. He used his Personal Assets to house and support the 4 Children until they got Further Education and Professional Qualifications. The 1st and 2nd Son acted as Estate Trustees. The 2nd Son had Financial Service Profession Status and Trust Accounting Expertise. He committed Capital Frauds + Income Frauds + Accounting Frauds against the Citizen Father, Taxation Frauds against the State and Claim Contempt Frauds against the Law Courts. The Trust Claim B01B0837 got Sale Order Breach Contempt Fraud Proof for the Beneficiary Father against the Trustee Son and Bank of Scotland. Cases B01B0837 + 2020 000968 + 2020 0742 got Contempt Immunity Fraud Proof for the Parliament Session Jurisdictions against the County Court, High Court and Court of Appeal. It was part of the Proof Sets needed for Unfitness Cases against Top Judges in Parliament. The Crown and Lord Bishops used them to decide the Corruption Remedy Conditions for the Parliament Session that opened on 11th May 2021. It needs use of Total Trap Cases for Integrity Tests of Low Rank Judges before the Unfitness Cases get Mass Publicity. The B01B08237 Total Trap Test was to discover whether or not it got the Remedy Order and the Stated Reasons.
