Bail Condition Revocation + Prosecution Case Dismissal + Contempt Fraud Remedy Application

Grounds: Fraudulent Breach of Natural Justice + Human Rights + Overriding Justice Objective

Remedy Proposals

1. Charge Officer Identity Fraud Finding + Contempt Fraud Finding + Contempt Remedy Entitlement Finding + Contempt Remedy Priority Finding + Bail Conditions Revocation Order + Prosecution Case Dismissal Order + Contempt Fraud Investigation Order for Citizen Mr Akwasi Nkrumah against the State for the Stated Reasons that:
 - 1.1. The Epaulette Officer Number 72805 was used by Two Charge Event Officers on 8th June 2021. It is Identity Fraud Conspiracy Proof against both of them.
 - 1.2. Fraud Proof on anything gets a Proof Burden Reversal for the Victim against the Fraud Managers and the Fraud Beneficiary.
 - 1.3. The Proof Burden Reversal gets a Fraud Conspiracy Presumption for Citizen Mr Nkrumah against Essex Police as the Investigating Authority and All Officers involved in every stage of the Complaint + Arrest + Investigation + Trial Fitness Certification Process + Charge + Bail Process
 - 1.4. A Crime Partnership of Top Judges and Top State Officers in the Ministry of Justice provided Crime Management Services conditional upon Fraud Commitment Proof from Organised Criminals.
 - 1.5. A Land Fraud Conspiracy needed Tenancy Forgeries by Housing Association Officers as Fraud Commitment Proof for the Ministry of Justice Crime Partners.
 - 1.6. Forgery Complaints by Citizen Mr Nkrumah got Protection Fraud Demands by Housing Association Officers from the Ministry of Justice Crime Partners. They got a Ruin Fraud Conspiracy against Citizen Mr Nkrumah that started with Crime Framing Frauds by the Metropolitan Police. A Profit Share Request by the Metropolitan Police got a Request Refusal by the Ministry of Justice Crime Partners and Service Refusals by the Metropolitan Police that created a Ruin Fraud Dependency on Ministry of Justice Officers. Prison Release Habeas Corpus Claims got Issue Denial Contempt Frauds Proof against the Administrative Court a Liability Admission + Settlement Offer by the Secretary of State for Justice, Claim Issue + Dismissal Contempt Frauds + Appeal Dismissal Frauds by Top Judges. A True Appeal by Citizen Mr Nkrumah discovered an Appeal Fraud by Ministry of Justice Officers got an Appeal Dismissal Fraud by Top Judges.
 - 1.7. Citizen Mr Nkrumah discovered the Parliament Session Jurisdictions. He gave use of his cases for the Corruption Remedy Process. The first was Prison Release Licence Condition Breach Trial Frauds that used a Prison Release Forgery. A Conflict Jurisdiction Disqualification Plea got Plea Rejection Frauds + Repeat Plea Hearing Frauds + Hearing Attendance Prohibitions against Both Parties Frauds + Case Process Misrepresentation Record Frauds + Responsible Individuals Identity Misrepresentation Record Frauds + Public Gallery Witness Intimidation Frauds + Case Withdrawal using a Public Interest Reason Fraud. The result was Fraud Conspiracy Proof against All Law Courts including the Supreme Court.
 - 1.8. Ruin Fraud Disasters motivated Liable Officer to demand Protection Frauds. They got a Repeat Ruin Fraud Conspiracy by the Crime Partners in the Ministry of Justice and Metropolitan Police.
 - 1.9. On 11th January 2021 a Freak Event got an Immediate Unprepared Fraud Conspiracy Execution Order. There was no time for a Resource Allocation Order for the Framing Fraud Specialists. It got Night Duty Officers who thought they needed Multiple Obvious Frauds to get Protection Fraud Reassurance from Crown Prosecutors and Law Court Judges. They used Shea Butter for a White Substance Drug Suspicious Fraud + Arrest Fraud + Custody Fraud + CAD 6559 11 01 2021 Investigation Frauds + Self Inconsistent Record Frauds + Trial Fitness Certification Fraud + Family Sabotage Bail Conditions Conspiracy Fraud + Child Care Frauds against Citizens Mr and Mrs Nkrumah
 - 1.10. On 1st February 2021 the Bail Conditions Revocation Application Hearing discovered the use of a Defence Witness Court Building Exclusion Fraud Order for a Fraud Conspiracy Testimony Exclusion Fraud by the Crown Prosecutor and then a Confidence Loss and No Contest Decision for Citizen Mr Nkrumah and then a No Contest Decision for Citizen Mrs Nkrumah.

- 1.11. A Secret Withdrawal by the Crown Prosecution Service of the Drug Crime Framing Fraud Trial Fitness Certificate got Trial Continuity Pretence Frauds + Protection Frauds Demands by the Metropolitan Police
- 1.12. The Drug Crime Framing Fraud Bail Conditions Confidence Collapse of the Crown Prosecutor broke the confidence of Local Authority Child Case Officers for the Child Access Denial Frauds but not for removal of the Drug Crime Parent Unfitness Defamation Frauds + Neglect Defamation Frauds
- 1.13. The Drug Crime Trial 2020 7219 Case Management provided Similar Fact Evidence for Defendant Mr Gordon against the State and Law Courts to that got by the Ruin Fraud Conspiracy against Citizen Mr Nkrumah. He decided to provide Investigation Services for the parliament Session Jurisdictions. He did not have the Case Management Expertise to get a Reliable Flow of Proof Sets that met the Corruption Remedy Proof Standard. He did get some. An Integrity Test got Conflict Disqualification No Jurisdiction Plea Denial Advice from the Defence Representatives. The Trial Judge Mr A Greenwood used a Mobile Phone Usage Allegation Fraud for a Contempt Finding + Court Room Exclusion Fraud that denied the Parliament Session Jurisdictions the benefit of Public Gallery Reports from Citizen Mr Nkrumah. Decision Proof Denial Frauds prevented a Fraud Appeal by Citizen Mr Nkrumah. All of it adds to the Bias Fraud Conspiracy Suspicions for Mr Gordon against the State and Law Courts.
- 1.14. On the evidence available the Protection Fraud Demands by the Metropolitan Police got the Emergency Worker Assault Framing Fraud by Essex Police.
2. A Bias Contempt Fraud Finding for Citizen Mr Nkrumah against the State for the Stated Reason that Party Equality before the Law Courts for the Citizen and State Officer requires use of Common Law
