Observations

Citizen Papers do the Case Representation Work. Case Papers Filing by the Citizen or Equity Lawyer gets either a Court Print in the Court Room or Evidence Exclusion Fraud Proof against the Court Officers and a Case Papers Presentation Opportunity for the Citizen in the Court Room. The Hearing Management Choice is either Silent Reading by the Judge or Loud Reading by the Citizen. The Court Lawyer sat so that he could observe the Magistrates. Body Language raised Reasonable Suspicions that a Judgment Adjournment would get Remedy Representations by the Silent Magistrate. The Decision Prompt by the Court Lawyer prevented a Judgment Adjournment. Corrupt Officers use Hearing Management Incompetence as a Case Qualification for Case Allocation Frauds. Magistrates Chairman lacked the Reputation Defence Skill to resist Influence Frauds by the Court Lawyer. All of it was Blatantly Obvious to the Equity Lawyer.
