Case Dismissal Representations

The Parliament Session Jurisdictions conducted a Corruption Remedy Process. It discovered Computer Record Frauds by the Ministry of Justice and Law Courts. They were Identity Concealment Frauds and Identity Misrepresentation Frauds and Case Misrepresentation Frauds. The Remedy Process needed a Record Fraud Case for Integrity Tests. Corruption Cases got Fraud Conspiracy Proof for Citizen Mr Nkrumah against the State and Law Courts. He agreed to conduct Integrity Tests for the Remedy Process.

The Corruption Summons Application of Citizen Mr Nkrumah against the Emergency Worker Assault Case Officers + Custody Officers got an Application Process Denial Fraud by the Magistrates Court Officers that used either a Record Denial Fraud or Record Fraud + Notice Denial Fraud against the Magistrates Court. It is Bias Fraud Proof for the Parliament Session Jurisdictions against the Magistrates Court

The Emergency Worker Assault 422100145 155 Bail Condition Revocation + Contempt Remedy Application got from the Magistrates Court Office at Chelmsford:

1. A Remand Misrepresentation Record Fraud

On 4th July 2021 a Royal Commission Email + Attachments from the Equity Lawyer was Evidence Offer + Evidence Details Filing Proof for the Parliament Session Jurisdictions against the State and Law Courts and Filing Notice Proof for the Parliament Session Jurisdictions against the Cabinet and Parliament. It got an Evidence Production Refusal Fraud Proof against the Court Officers.

On 5th July 2021 a Defence Witness Appearance got the Entry Queue Front Position for Equity Lawyer Mr Ellis . A Defence Witness Status Notice from him got an Entry Refusal by the Entry Desk Officer. An Integrity Test Notice from the Equity Lawyer explained that the Parliament Session Jurisdictions had managed a Remedy Process that got Corruption Proof for Dismissal Decisions against Top Judges. The Remedy Process used Integrity Test Cases to discover whether Top Judge Dismissal Case Notices got Remedy Proof for Lower Rank Judges or Remedy Denial Fraud Proof against them. He explained that on 1st June 2021, at a Land Fraud Test Case Hearing, the Temporary Judge ignored Permanent Appointment Denial Fraud Blackmail and made an Adjournment Order + Case Reference to Permanent Judges. He explained that a Fraud Revocation Hearing on 9th July 2021 would force a Permanent Judge to choose between the Remedy or Enforcement of Court Frauds he had committed but dare not complete for the last 4 years. He explained that Forces Personnel risked their lives in the Falklands Campaign, Desert Storm, Afghanistan, Iraq and Elsewhere. They did so as Just Culture Representatives for the Crown and People of the United Kingdom. Some of them got Court Security Offices and received Exclusion Fraud Orders against Defence Witnesses to service Trial Fraud Conspiracies by the State and Law Courts. The Entry Queue Front Position by the Equity Lawyer got Position Vacation Requests by the Reception Desk Officer, that got Position Vacation Refusal by the Equity Lawyer, that got a Forced Removal Order from the Reception Desk Officer, that got a Forced Removal Approach by the Security Guard, that got a Forced Removal Commitment Question from the Equity Lawyer and a Forced Removal Refusal by the Security Guard. The Equity Lawyer kept the Entry Queue Front Position for 40 Minutes until a Confidence Loss got an Admission Decision by an Anonymous Officer. The County Court Security Manager appeared part way through and listened with Intelligent Interest.

The Case Call got Personal Appearances by Citizen Mr Nkrumah and Equity Lawyer Mr Ellis.

The Court 4 Public Gallery is divided by an Entry Passage. The Right-Hand Half had 10 or 12 Vacant Seats. A Vacant Seat Occupation by the Equity Lawyer got a Hostile Change Seat Order

Fraud by the Court Lawyer using a Covid Health Protection Reason Fraud and the Usher as Enforcement Agent. The fact the Equity Lawyer was the Sole Occupant of the 10 to 12 Seats and the Obvious Hostility got Fraud Status for the Health Protection Reason and Enforcement Decision. In the circumstances of the case, it was a Domination Fraud and Witness Intimidation Fraud.

The Identification Process got Identity Admissions from the Citizen and Identification Denial Fraud Proof for the Parliament Session Jurisdiction against the Court Lawyer and 2 Lay Magistrates.

Then the Anonymous Court Lawyer sat so that he was not facing the Parties but sat sideways so that he could see the Body Language of the 2 Anonymous Magistrates. A Remand Hearing Claim and a Bail Variation Hearing Purpose Notice from the Court Lawyer added to the Remand Hearing Misrepresentation Fraud Conspiracy Proof and a Contempt Remedy Application Denial Fraud Conspiracy Proof for the Parliament Session Jurisdictions against the Anonymous Court Lawyer and Other Court Officers.

An Evidence Production Refusal Fraud by the Anonymous Court Lawyer got an Evidence Print Offer by the Citizen that got a Print Refusal + Oral Representations Only Demand + Covid Regulations Reason Fraud by the Magistrates Chairman. The Personal Representation by the Lay Citizen got Representation Assistance Rights and Representation Assistance Denial Fraud Conspiracy Proof against the Anonymous Crown Prosecutor, Anonymous Court Lawyer and Anonymous Magistrates. A Witness Call by the Citizen got No Response from the Anonymous Court Lawyer and Anonymous Magistrates. It got a Witness Box Appearance by the Equity Lawyer and Oath Process Hesitancy by the Court Usher. An Integrity Test Notice from the Equity Lawyer got an Integrity Test Denial Fraud by the Anonymous Magistrates Chairman that was accompanied by a Crestfallen Look and Finger Fiddling by the Silent Anonymous Magistrate that raised reasonable Suspicions that a Judgment Adjournment would get Hearing Management Criticisms by the Silent Magistrate against the Chairman. A Parliament Session Jurisdiction Remedy Process Notice and Brief Explanation by the Equity Lawyer that got Hostile Interruption Frauds by the Anonymous Magistrates Chairman and a Witness Call Refusal by the Anonymous Court Lawyer. It got a Test Failure Notice from the Equity Lawyer and an Advice Adjournment Order from the Anonymous Magistrates Chairman. The Anonymous Court Lawyer dare not risk a Judgment Adjournment. He gave a Decision Prompt that got an Application Dismissal Pronouncement by the Anonymous Magistrates Chairman. The Citizen and Equity Lawyer left the Court Room.

A Test Failure Brief Explanation from the Equity Lawyer got Respectful Attention from the Security Guard on the Court Floor. Citizen Mr Nkrumah checked the Video Cameras. The Leaving

The Respectful Interest and Apologetic Behaviour of the Support Staff got a Case Transfer Fraud by Corrupt Officers from Southend to Stevenage.

The Hearing Event got the Integrity Test Report dated 5th July 2021 and Plea Hearing Proposals and Royal Commission Filing and Service Email dated 7th July 2021 from the Equity Lawyer.

The Hearing Event got the Bail Conditions Weekly Reporting Record Fraud + Plea Hearing venue Change Notice Fraud dated 8th July 2021 from the Chelmsford Officer of the Magistrates Court.

The Police Bail Weekly Reporting Condition + 70 Mile Round Trip Imposition is Before Trial Liberty Restraint Fraud + Travel Cost Fraud Proof against Essex Police.

The Police Bail Weekly Reporting and the Court Bail Weekly Reporting Condition and the Remand Prisoner Production Evidence Deficit are Record Fraud Proof + Liberty Restraint Fraud + Travel Costs Fraud Conspiracy Proof against Essex Police and the Law Court.

Record Fraud Similar Fact SAMPLE Cases

1. A Criminal Appeal by Citizen Mr Nkrumah discovered that Court Officers used a Secret Appeal Forgery to get a Secret Appeal Process + Secret Appeal Dismissal Fraud.
2. A Prison Release Habeas Corpus Claims by Citizen Mr Nkrumah and his Wife got Issue 2 Year Denial Fraud Proof against the Administrative Court. Then a Claim Issue Denial Liability Admission + £30 Settlement Offer by the Secretary of State for Justice, and then a £200 Settlement Offer, and then Claim Issue by the Administrative Court, and then Claim Dismissal Fraud + Civil Restraint Fraud by the Administrative Court, then and Appeal Dismissal Frauds + Civil Restraint Continuity Fraud by the Court of Appeal, and then Protection Frauds + Restraint Fraud Continuity by the Supreme Court.
3. An Imprisonment Fraud Conspiracy used a Release Licence Forged Record Fraud for a Licence Breach Prosecution Fraud. All of the Witnesses, Investigators, Prosecutors and Adjudicators were Justice Ministry Officers. The Conflict Disqualification got a Forgery Complaint + No Jurisdiction Plea Notice from the Citizen. The Plea Hearing Appearance got Bias Fraud Proof for the Caucasian Equity Lawyer against the Black Court Lawyer. It got No Legal Qualification Admissions and Decision Authority Denials by the State Representative. It got Positive Bias Behaviour and Adjournment Advice from the Black Court Lawyer to the Black Magistrate for the Black Citizen. It got Enthusiastic Power Crazy Behaviour + Blatant Bias + Adjournment

Advice Rejection + Trial Order + Case Reservation by the Black Magistrate for Himself against the Black Citizen. It got Record Frauds and Repeat Adjournments Frauds that included Hearing Attendance Prohibition Frauds against both the Prosecution and the Defence and a Repeat Plea Hearing and a Secret Case Withdrawal Notice from the Prosecutor to the Court, a Case Withdrawal Notice Denial Fraud by the Prosecutor against the Citizen, a Continuing Case Pretence Fraud + Trial Fraud Intimidation by the Judges, and Intimidation Frauds by Court Officers against Public Gallery Witnesses, and a Case Withdrawal Notice Admission and Withdrawal Wasted Costs Application Filing Denial Fraud + Hearing Fraud by the Judge.

4. Fraud Conspiracy Failures by State Officers and Court Judges gets Repeat Fraud Conspiracies.
5. On 11th January 2021 a Discipline Incident by Mother prompted a Father Access Run-Away Decision by a 10-year-Old Girl. It got a Child Risk Finding Fraud and use of a Half – Eaten Shea Butter Pack for a White Substance Suspicion Fraud + Drug Crime Investigation Fraud + Custody Fraud + Family Sabotage Bail Conditions Fraud by the Metropolitan Police. It got use of the Bail Conditions Fraud for a Family Sabotage Enforcement Frauds by the London Borough of Barking and Dagenham Council. The Bail Condition Revocations Applications got a Bail Condition Revocation Hearing Notice for 1st February 2021. A Witness Appearance by the Equity Lawyer got a Witness Exclusion Order Fraud from the Crown Prosecutor to the Reception Desk Officer and the Reception Security Officers and then Application Resistance + Confidence Collapse + Late Resistance Withdrawal by the Crown Prosecutor for the Citizen and then Continued Resistance + Confidence Collapse + Even Later Resistance Withdrawal by the Crown Prosecutor against the Wife. It got a Confidence Collapse + Children Returns by the Child Case Officers, and then Continued Use of the Drug Crime Defamation Frauds + Risk Finding Frauds in the Child Case Records.

The Fraud Motive Explanation

Politicians agreed the European Constitution. It vested Dictator Powers in the State. In every Member State of the European Union the Politicians lost control to State Officers and Law Court Judges who formed Crime Partnerships. They developed Protection Fraud Networks for Support Services and Corruption Co-ordination. They sold Market Frauds to Organised Crime, provided Protection Frauds for the Corrupt Officers who managed them, and traded Glittering Career Guarantees and Job Profits in exchange for Fraud Services by Corrupt Parliamentarians. General Elections got Governing Majorities that were subject to Remedy Denial Fraud Majorities controlled by the Protection Fraud Network.

Top Judges were not satisfied with Protection Fraud Fees. They wanted Crime Profits. Top Judges and Top State Officers formed the Justice Ministry Crime Partnership. It managed the Protection Fraud Business and provided Management Services + Protection Frauds for Other Crime Business. The Protection Fraud Market has Risk Control Protocols. The Worst Risk is Immunity Deals that get Fraud Conspiracy Proof against Top Judges. The Risk Control Protocol requires Fraud Commitment Proof from the Receiver before the Protection Fraud Supply. Routine Business uses Case Frauds as Fraud Commitment Proof. Special Business requires New Frauds as Fraud Commitment Proof. Very Special Business requires Fraud Commitment Proof from the Law Courts that give the receivers the confidence to commit New Fraud as Fraud Commitment Proof before the Protection Fraud Supply.

A Land Fraud Conspiracy required Tenancy Forgeries by Housing Association Officers as Fraud Commitment Proof before the Protection Fraud Supply by Top Judges. A New Tenancy Notice was Forgery proof that got Forgery Complaints by Citizen Tenant Mr Nkrumah and a Ruin Fraud Conspiracy against him. The Emergency Worker Assault Trial Frauds are the latest in the series.
