War Booty Financial Service Request Communications Log Confirmation or Completion Request by the Equity Lawyer to Citizen Mr Sood and US Military Dr Katherine Elliot. The Word Version is provided in case it is needed for completion.

Suspicious Circumstances

1. The UK Parliament Session Jurisdictions have conducted a Corruption Remedy Process. It uses Corruption Investigations and Remedy Management Investigations.
2. Trust Claim Fraud B01B0837 + Emergency Worker Assault Trial 2100096661 + Other Cases got Corruption Proof that enabled use of them for Remedy Management Investigations. In 2021 the Remedy Investigations used Top Judge Dismissal Case Notices for Integrity Tests to discover whether they get Remedy Proof for Lower Rank Judges or Remedy Denial Fraud Proof against them.
3. Trust Fraud Claim got a Hearing Notice and a Case Allocation by Permanent Judges to a Temporary Judge. On 1st June 2021 the Temporary Judge used a No Case Papers Reason for an Adjournment Order and Case Allocation to the Permanent Judges and a Hearing Priority Notice for the Trust Beneficiary against the Trustee. Case Allocation Decisions need the Case Papers. The Case Allocation + Hearing Priority Notice needed Case Knowledge that is inconsistent with the No Case Papers Claim by the Temporary Judge. It is Enforcement Delay Proof + Settlement Influence Proof + Remedy Denial Proof. Investigation is needed to discover whether or not to make a Fraud Finding against the Temporary Judge.
4. On 5th July 2021 the Emergency Worker Assault Trial 422100145155 Preliminary Issue Hearing got an Integrity Test and Total Failure Finding and Test Report dated that day.
5. The Royal Commission + Integrity Test Report Filing Email dated 7th July 2021 got a Secret Conflict Disqualification Admission + Secret Hearing + Hearing Denial Fraud + Without Hearing Case Transfer

Fraud dated 8th July 2021 by Essex County Magistrates to Hertfordshire County Magistrates + 14th July 2021 Plea Hearing Venue Notice for Stevenage Magistrates Court.

6. The Emergency Worker Assault Trial 422100145155 Transfer got Case Reference 2100096661 + No Offence URN + No Info Laid Date + No Crime No + Secret Hearing Fraud Orders from Stevenage Magistrates Court.
7. On 14th July 2021 the Emergency Worker Assault 2100096661 Plea Hearing got a No Jurisdiction Plea and Crown Court Election and Case Dismissal Application by the Citizen. The Crown Prosecutor and Court Lawyer needed a Preparation Adjournment for the Case Dismissal Application. They used the absence of the Citizen to make a Fraud Conspiracy Plan. A Public Gallery Access Demand by the Equity Lawyer discovered the Fraud Conspiracy Plan. The Fraud Exposure got an Angry Response + Violent Eviction Frauds against the Equity Lawyer and then the Citizen. The result was a Conflict Disqualification Admission + Fraud Conspiracy + Conspiracy Exposure + Unfinished Hearing. The choice for Hertfordshire Magistrates is Give Up or Carry On.
8. When the Protection Fraud Network is in difficulties it uses Entrapment Frauds.
9. The War Booty Financial Service Request Email Series started about 15 hours after the Eviction Frauds.
10. On 16th July 202 the Equity Lawyer went on line and found the Forward Email from Citizen Mr Sood.
