1. The Citizen, Crown and Lord Bishops have Corruption Control Jurisdictions that govern parliament Session Powers. Since 2004 they have managed a Corruption Remedy Process. It uses Corruption Investigations and Remedy Investigations to get Remedy Management Proof Sets
2. The Parliament Session that opened on 19th December 2019 got a Complete Set of Criminal Conspiracy Proof for Unfitness Cases against Top Judges in Parliament.
3. The Parliament Session that opened on 11th May 2021 needed to discover whether Top Judge Dismissal Case Notices + Integrity Test Notices got Remedy Proof for Lower Rank Judges or Remedy Denial Fraud Proof against them.
4. The Civil Case Tests got use of No Case Papers reasons for Adjournment Orders
5. The Criminal Case Tests used the Emergency Worker Assault
6. The Police Bail Weekly Reporting Condition was a Before Trial Liberty Restraint + Liability Costs Imposition Fraud
7. The Integrity Test used the Corruption Summons Application + Contempt Remedy Application + Police Bail Condition Revocation Application.
8. The absence of Police Custody and Prisoner Production and a Remand Application by the State and the Court Bail Order is Fraud Conspiracy Proof against the Essex Magistrates and Southend Magistrates Court
9. The Integrity Test Failure Notice + Report dated 5th July 2021 is an Official Record and Admission Evidence for the Parliament Session Jurisdictions.
10. The Royal Commission + Integrity Test Report Filing Email dated 7th July 2021 got a Conflict Disqualification Admission + Conflict Qualification Fraud + Secret Hearing + Case Transfer Fraud. The Register Entries are the Record Fraud Proof
11. On 14th July 2021 the Plea Hearing + Integrity Tests Notices got Hearing Fraud Conspiracy Proof and Public Gallery Access Denial Fraud Conspiracy Proof + Violent Eviction Fraud Conspiracy Proof against the Security Manager + Security Guard + Usher + Crown Prosecutor + Court Lawyer + Court Manager. A Violent Justice Perversion Fraud Conspiracy Summons Application against them will either get either Remedy proof for the Magistrates Court or Bias Fraud Conspiracy Proof against it.
12. The Integrity Test needs an Immunity Negotiation Offer Test. It will enable Cross Examination of Police Officer Witnesses in the Emergency Worker Assault Trial to discover whether or not they want an Immunity Negotiation Adjournment because the Criminal Liability Caution.
