1. Fraud Appeal Intent Notice to the Crown Prosecution Service and Magistrates Court for the Stated Reasons that:
 - 1.1. Fraud Admissions + Fraud Conflict Disqualifications Admissions by Essex Magistrates created a Remedy Only Jurisdiction Limit that should have got a Remedy Hearing but instead got a Remedy Only Jurisdiction Limit Breach Fraud + Conflict Qualification Fraud + Case Transfer Fraud to Hertfordshire Magistrates
 - 1.2. The Plea Hearing got a Case Dismissal Application + No Jurisdiction Plea + Crown Court Jurisdiction Election by Citizen Mr Nkrumah and a Crown Court Jurisdiction Election Denial Fraud + Magistrates Court Election Pretence Fraud + Trial Order Fraud + Other Frauds
