  - 1.1. The Fraud Conspiracy Proof includes the Fraud Appeal QB 2018 0239 Issue Proof + Case Process Proof against the High Court and the Subject Access Request 210510024 that got Case Record Denial Response Email at 15.38 on 29<sup>th</sup> July 2010 from Ministry of Justice Knowledge and Information Liaison Office <[LondonKILO@jsutice.gov.uk](mailto:LondonKILO@jsutice.gov.uk)> of the High Court QB 2018 0239 Case Record and Any Case Record that has Mr Francis Zarb as a Case Party.
  - 1.2. The Corruption Remedy Process of the Parliament Session Jurisdictions motivated Corrupt Officers to use Case Misrepresentation Frauds + Identity Misrepresentation Frauds + Record Destruction Frauds as Protection Frauds for Organised Criminals + State Officers + Law Court Judges.
  - 1.3. The 2007 Parliament Session Priority required a Validity Priority Precedent. The House of Lords set it using 2008 Case R v Clarke. It imposes a Validity Investigation Obligation on the Law Courts. The Record Denial Evidence raises Fraud Suspicions and makes a Validity Investigation the Case Priority.
  - 1.4. The Eviction Claim D00BT669 and Fraud Appeal QB 2018 0239 and Enforcement Claim F00LE923 got Corruption Proof and Remedy Denial Fraud Proof that in September 2019 enabled a Corruption Case Use Offer by Citizen Mr Zarb to the Parliament Session Jurisdictions. It got Case Management Services by Equity Lawyer Mr Ellis that was subject to Remedy Co-operation Conditions. It got Passive Protection Rights for the Citizen from the Crown and Parliament with Enforcement Obligations against the Cabinet and Prime Minister, and Enforcement Accountability Obligations against the Opposition Leader. Passive Protection Rights get Rights Enforcement or Enforcement Failure Accountability or Rights Denial Fraud Conspiracy Proof against the Cabinet, Prime Minister and Opposition Leader.

The Victim Circumstances included that of a British Born Child of an Immigrant Parent and Immigrant Grand Parents + Profession Standards that got Computer Engineer Employment at the System Architect Level by the Atomic Energy Authority + National Computer System Development Experience + Career Maturity that coincided with the use of Computer System Development Budget Frauds that got £1,000,000 Per Day Write Offs from 1997 to 2010 by the Labour Governing Majority + Multi Million Pound Budget Fraud Whistle Blower Warnings for the National Health Service + Secret State Employment Denial Fraud + Multi Million Pound Budget Fraud Whistle Blower Warnings for the Global Corporate known as Reuters + Secret Global Corporate Employment Denial Fraud + The Priority Decision by Prime Minister Mr Cameron for the European Referenda against Top Judge Dismissal Cases because the Corruption Exposure would get Leave Votes, and Remain Campaign Leadership by Prime Minister Mr Cameron, the Leave Result that got a Honourable Resignations from him that prevented him from managing the Top Judge Dismissal Cases, and the need for the Protection Fraud Network to have Protection Frauds from the Next Prime Minister, the purchase of Leadership Votes for MP Mrs May because she was part of the Protection Fraud Network, the New Frauds against Corruption Whistle Blowers required as Fraud Commitment Proof before the Protection Fraud Supply from Prime Minister Mrs May that coincided with the Ruin Fraud Conspiracy against Citizen Mr Zarb using Lodger Obligation Breach Frauds + Harassment Frauds by Lodger against Landlord + Breach Remedy Eviction + Harassment Crime Investigation Denial Frauds by Leicestershire Police and Metropolitan Police against the Citizen + Harassment Crime Complaint Allegations by the Lodger + Eviction Claim Fraud + Papers Service Denial and Delay Frauds + Notice Denial Frauds + Trial Frauds + Liability and Costs Frauds dated 5<sup>th</sup> July 2018 + Appeal Case Reference QB 2018 0239 alias CC 2018 ANC 0239 B Pending Appeal Enforcement Stay Delay Frauds + Costs Assessment Frauds + Appeal Permission Refusal Fraud dated 22<sup>nd</sup> March 2021 + Enforcement Claim Fraud F00LE923 + High Court Records Denial Frauds + Similar Fact Record Fraud Cases against the Ministry of Justice and Law Courts + 2021 Parliament Session Integrity Tests got Remedy Denial Fraud Proof against Law Courts and Increased Mass Remedies Obligation of Parliament
