Claim: Contempt Fraud Conspiracy to pervert the course of justice + Malicious Prosecution:

1. Use of Legislation Frauds for Justice Jurisdiction Concentration against Justice Jurisdiction Separation
2. Use of Jurisdiction Concentration for Investigation + Prosecution + Adjudicator Appointments
3. Use of Jurisdiction Concentrations for Conflict Qualification Frauds
4. Use of Jurisdiction Concentration to sell Governance Frauds for Organised Criminals against Citizens
5. Use of Case Management False Advice for False Jurisdiction and False Claims
6. Use of Internet Publicity for the False Advice to attract Corruption Complaints
7. Use of Provocation Agents to assist Corruption Complaints to make False Jurisdictions for False Advice
8. Use of the False Jurisdictions and False Claims for Mental Unfitness Allegations
9. Use of Standard Forms for Evidence Exclusion Frauds
10. Use of Career Bribery and Career Blackmail to get Fraud Services from Relevant Professionals
11. Use of Profession Authorities for Unfitness Investigation + Prosecution + Adjudication Frauds
12. Use of Before Trial Execution Powers for Intimidation Frauds

The Corruption Proof against the General Osteopathic Council and the Law Courts includes

1. Corruption Complaints in more than 200 Constituencies that in 2000 got a Corruption Debate and an Investigation Commitment and Pending Investigation Adjournment and a Business Deal that got Protection Frauds for the General Osteopathic Council and Pharmaceutical Industry in exchange for 2001 General Election Campaign Finance for Prime Minister Mr Blair. Fraud Proof on anything gets a Proof Burden Reversal for the Victim against the Fraud Manager and the Fraud Beneficiary. The Investigation Denial Fraud Proof against the Labour Governing Majority is Fraud Proof that gets Victim Status and a Proof Burden Reversal for All Osteopaths against the General Osteopathic Council
2. In 2004 preparations for the European Referenda got Criminal Conspiracy Proof against Prime Minister Mr Blair and other European Leaders. Equity Lawyer Mr Ellis used it for a Corruption Notice to the Crown and Parliament. It got Revived Use of the Parliament Session Jurisdictions after a Dormancy Period of 45 years.
3. A Long Criminal Trial got Jury Tampering Fraud by the Organised Criminals with Imprisonment Frauds in a Middle Eastern State to prevent Citizen Ms Lewis giving Jury Tampering Evidence. The Case Collapse got an Immediate Release by the Middle Eastern State. before the Case Collapse. Profession Unfitness Frauds by the General Osteopathic Council against Citizen Ms Tracey Lewis A Case Use Authority from her enabled the Review Frauds + Appeal Frauds to get Fraud Conspiracy Proof for her and the Parliament Session Jurisdictions against the Investigators, Prosecutors and Adjudicators of the General Osteopathic Council and the Metropolitan Police, and Review Frauds + Appeal Frauds + Restraint Frauds added it against the Administrative Court and the Court of Appeal. It includes an Audio Record that is Restraint Fraud Conspiracy Proof for Equity Lawyer Mr Ellis and the Parliament Session Jurisdictions against the General Osteopathic Council, Their Representative and High Court Justice Mr Foskett.

Shop Theft Claims 2019 03741 + 03984 that got Trial Denial Fraud Conspiracy Proof for the Parliament Session Jurisdictions against the Shop Thieves, Claim Representatives, Defence Representatives, Court Officers, Top Judges and the Metropolitan Police. A Shop Theft Conspiracy that used Crime Framing Frauds to get Insolvency Conditions and a Forced Sale and Premature Possession and Sale Price Payment Default Frauds. The 1st Framing Fraud used Perjury Immunity for 3 Women Witnesses for Harassment Trial Frauds with Audio Records. The Crown Court Judge noticed Innocence Evidence Concealment Frauds, supervised the Audio Records of an Acquittal Decision by a Lay Jury and Claim Advice from the Trial Judge for the Victim against the Metropolitan Police, Ministry of Justice and Defenders. A 2nd Framing Fraud with Planted Evidence that got a Health Regulation Breach Finding Fraud + Business Closure + Insolvency Conditions + Forced Sale + Guilty Plea + Sale Price Part Payment with a Premature Possession Request and Full Payment Representation Frauds + Premature Possession + Full Payment Refusal. A Shop Theft Complain by the Victim got Investigation Denial Fraud Proof against the Metropolitan Police. Shop Theft Claims 2019 03741 + 03984 got a 2019 03741. The Protection Fraud Protocol requires Fraud Commitment Proof from the Receiver before the Protection Fraud Supply. The Fraud Commitment Proof from the Shop Thieves and Representatives was a Defence + Counterclaim that used an Unjust Enrichment Reason for the Sale Price Payment Refusal. The Court Protection Fraud was a 1st Back Dated Forged Order for a 30-Day Stay + Particulars Filing 30 Day Time Limit + Compliance Default Dismissal and Service Denial Order Fraud to get the Compliance Default. The Fraud Commitment Proof from the Metropolitan Police was use of the Shop Theft Complaint for Case Allocation Order + Complaint Acknowledgement + Complainant Interview. On Decision Day 27 the Victim got Letter Box Service of the Sealed Forged Order. The Complainant Interview got a Case Presentation by the Equity Lawyer and a Case Reference to Superior Officers and an Investigation Denial Fraud. It got a 2nd Backdated Forged Order and Letter Box Service. The Seal Ink was Forensic Test Material. A Forensic Test Sabotage Fraud Plan that needed the original Case Papers to enable either Evidence Destruction or Forgery Substitution. It used Sale Contract Enforcement Claim G02EC632 and a Hearing Notice to force the Victim to consult Qualified Lawyers and used them to get the Original Case Papers. It failed. It got Royal Commission Email Service of the PDF Scans by Equity Lawyer Mr Ellis and Evidence Preservation for the Parliament Session Jurisdictions. It got Case Management Fraud Conspiracy Proof against the Shop Thieves, Claim Repre3sentatives, Defence Representatives and the Law Courts includes Adjournment Consent Frauds + Costs Consent Frauds.

5. Similar Fact Record Fraud Evidence includes Fraud Appeal 2018 0239 Case Records that on 18th September 2019 got Interim Remedy Application Hearing in Royal Court 37 and an Interim Order. A 2021 Subject Access Request got a Total Denial of Any High Court Records of the Case or Parties
