Remedy Proposals

1. Corruption Case Finding + Corruption Remedy Process Finding + Remedy Process Integrity Test Notice Finding + Conflicted Interest Finding + Conflict Jurisdiction Disqualification Finding + Remedy Only Jurisdiction Limit Finding + Conflict Recusal Entitlement Finding + Recusal Failure Finding + Remedy Applications Exclusion Contempt Fraud Conspiracy Finding + Evidence Exclusion Contempt Fraud Conspiracy Finding + Bias Contempt Fraud Conspiracy Finding for the Citizen Mrs Theodorou and Parliament Session Jurisdictions against Respondent Mr Theodorou, His Representatives Galbraith Branley and Financial Applications Judge Mr Stone for the Stated Reasons:
  - 1.1. The Top Corruption Controls are General Elections and Parliament Session Corruption Remedy Priorities. General Elections change the Governing Majority. The Parliament Session Grant from the Crown to the Prime Minister define the Corruption Remedy Priorities.
  - 1.2. The European Dictator Governance Plan needed a Sabotage Fraud Set against the Citizen. It denied a Reliable Supply of Proof Sets that met the Corruption Remedy Proof Standard. It got a Dormancy Period for the Parliament Session Jurisdictions that lasted for 45 years. In every Member State of the European Union the Politicians lost control to State Officers and Law Court Judges who formed Crime Partnerships. They developed a Protection Fraud Network to provide Support Services and Corruption Co-ordination. They sold Market Frauds to Organised Crime, provided Protection Frauds for the Corrupt Officers who managed them and traded Glittering Career Guarantees and Job Profits in exchange for Fraud Services by Corrupt Parliamentarians.
  - 1.3. In 2004 Criminal Conspiracy Proof against the State and Law Courts enabled a Corruption Notice to the Crown and Parliament. It ended the Dormancy Period of the Parliament Session Jurisdictions. It started a Corruption Remedy Process that has continued ever since. It needed to achieve Total Destruction of the Protection Fraud Network.
  - 1.4. In 2014 the Protection Fraud Network made a Corruption Continuity Plan to avoid Total Collapse. It needed a Business Expansion Plan. They chose Family Sabotage Frauds + Children Thefts to get Big Budgets + Budget Fraud Profits and Expatriation Frauds to get Money Laundering Services from Sovereign States. They chose the Cypriot Community as the Target Community because it was very divided. They needed a Business priming Case to get Fraud Knowledge Admissions and Remedy Denial Fraud Commitments from hundreds of State Officers and Law Court Judges. They chose the Theodorou Family for the Business Priming Case. They did so because a Criminal Conspiracy deal got Fraud Co-operation from Mr Theodorou for the State in exchange for Divorce Property Frauds for him against Citizen Mrs Theodorou.

- 1.5. In 2016 Citizen Mrs Theodorou gave use of Divorce ZC14D02308 Property Case for the Remedy Process. At every stage it got Fraud Conspiracy Proof for the Parliament Session Jurisdictions against Mr Theodorou, His Representatives Galbraith Branley, the Directions Judges, Trial Judge Mr Stone and Appeal Judges. It contributed the Criminal Conspiracy Proof Sets needed for Unfitness Cases against Top Judges in Parliament. The Crown and Lord Bishops used to decide the Parliament Session Remedy Conditions in 2017, 2019 and 2021.
- 1.6. The 2021 Session Priorities were Responsibility Apportionment between Case Remedies by Law Courts and Mass Remedies by Parliament. It needed Integrity Test of the Law Courts between Session Opening Day on 11<sup>th</sup> May 2021 and the Summer Recess.
- 1.7. On 31<sup>st</sup> August 2021 the Public Gallery Rights Case + Court Record frauds Case got a Conflict Jurisdiction Deficit Admission + Conflict Disqualification Denial Fraud + Remedy Jurisdiction Denial Fraud + Case Transfer Fraud by Crown Court Judges from St Albans to Chelmsford. The Corruption Summons Application got a Refusal Decision and Refusal Notice Email dated 6<sup>th</sup> September 2021 from the Magistrates Court in spite of the fact the Jurisdiction Deficit Admission by the Crown Court was Contempt Fraud Conspiracy Proof.
- 1.8. The Land Frauds G02EC632 + F02ED793 + G00CR488 got Criminal Conspiracy Proof for the Victims and Parliament Session Jurisdictions against the Claimants, Claim Managers, Qualified Defence Lawyers and the Law Courts. The Trust Claim Fraud B01B0837 got a Case Allocation by Permanent Judges to a Temporary Judge. On 1<sup>st</sup> June 2021 the Temporary Judge used a No Case Papers Reason for an Adjournment Order and a Case Allocation to the Permanent Judges and a Hearing Priority Notice for the Citizen Beneficiary against the Guilty Trustee. A Sale Negligence Case is a Connected Case. It got Similar Fact Fraud Conspiracy Proof. Land Fraud F00LE923 got 2018 0239 Case Record Fraud Proof against the High Court. It increased the Mass Remedy Obligation of Parliament.
- 1.9. On 9<sup>th</sup> July 2021 the Divorce ZC14D02308 Property Frauds Revocation Hearing motivated a Secret hearing Fraud Conspiracy. It used a Conflict Recusal Refusal Fraud, No Case Papers Reason for an Adjournment Order and a 10<sup>th</sup> September 2021 Retirement Date Notice from Judge Mr Stone. Then it used Decision Service Denial Frauds + Adjournment Hearing Notice Denial Frauds + Appeal Process Denial Frauds. A Confidence Collapse got a Hearing Attendance Enquiry Email from the Appeal Judge that was a Secret Hearing Notice for the Citizen. The Secret Hearing got a Surprise Attendance + Chronic Stress Illness Adjournment Application by the Citizen was a last chance to avoid Fraud Completion before the Retirement Date. He took it.
- 1.10. Other Cases got Conflict Fraud Conspiracy Proof against Profession Authorities and Law Courts
2. All Property Case Orders Revocation + Contempt Fraud Conspiracy Liability Finding + Special and General and Aggravated and Exemplary Damages Order + Remedy Directions 1 Hour Hearing Order at on September 2021 for Citizen Mrs Theodorou against Mr Theodorou
