Citizen Ms Michelle Lisa Davies has Osteopath Registration 2855 issued by the General Osteopathic Council. She noticed Profession Governance Frauds. She served a Corruption Claim. It created a Conflict Jurisdiction Disqualification for Citizen Ms Davies against the General Osteopathic Council. Council Officers committed Conflict Qualification Frauds by using the Corruption Claim for a Profession Unfitness Presumption Fraud and Mental Examination Consent Demand Fraud. She gave a Privilege Waiver and Confidentiality Waiver and Case Use Offer for Corruption Investigations managed by the Parliament Session Jurisdictions. They use the Corruption Remedy Proof Standard. She got Case Management Services by Equity Lawyer Mr Ellis that ensured the case got Proof Sets that met that standard. She served a Conflict Disqualification Notice. The Council Officers ignored it. She included a Blackmail Consent Extortion Fraud Notice in the Mental Examination Consent Form. They committed an Evidence Exclusion Fraud used Compliance Failure Allegation Frauds and gave 7 Days' Notice of an Interim Suspension Hearing. She filed a Conflict Disqualification Declaration Claim and Interim Remedy Application in the High Court. An Anonymous High Court Justice used an Urgent Case Legal Opinion Requirement Fraud for a Hearing Denial Fraud. It adds to Fraud Conspiracy Proof that other cases got against the General Osteopathic Council and High Court. The Fraud Conspiracy Proof against Law Courts includes enforcement of a High Court 2018 0239 Costs Order and Total Denial of that case by the High Court. The General Osteopathic Council used the Institute of Osteopathy to provide Professional Indemnity Insurance. Conflicted Interest Enquiries + Insurer Approved Representative Independence Enquiries by her got Response Refusal Frauds by them. A
