

Most people do not know that the Parliament Session Jurisdictions have Dismissal Powers against Top State Officers and Top Judges. They use Equity Lawyers to manage Top Level Corruption Investigations. They do not use Custody Centres and Recorded Interviews. They use Victim Cases to get Known Fraud Proof for Remedy Tests of the State, Profession Authorities and Law Court.

The Profession Indemnity Insurance Frauds are likely to be of most interest to All Professionals.

The General Osteopathic Council sells Professional Indemnity Insurance Policies. They control the Insurer Approved List of Experts and Representatives. They control the Claim Process. They control the Defence Case. They use Approval Termination Blackmail to get Case Management Frauds by Defence Experts and Defence Representatives against Profession Members.

A Mental Examination Consent Demand by the Council got a Conflict Disqualification Notice from Edward. A Repeat Demand by the Council got a Blackmail Consent Extortion Fraud Notice and Case Management Advice from Edward that the GP make Profession Guidance Application to the General Medical Council. A 7 Day Notice for an Interim Suspension Hearing by the Council got Insurance Conflict Enquiries by Edward and No Response from the Insurers or Council. A Contempt Fraud Claim by Michelle got a £10,000 Court Fee Demand from the High Court. A Fee Scale Questions by Michelle got No Fee Scale and High Court Listing Office Telephone Number from the Fee Officer. An Interim Remedy Urgent Hearing Application and £100 Court Fee got Hearing Refusal Fraud Proof in Friday 10th September 2021 against the High Court. A Hearing Condition Fraud by an Anonymous Judge required an Urgency Opinion by Qualified Lawyers. An Insurer Representation Refusal Fraud on Tuesday 14th September 2021 by the Council denied use of the Insurer Approved Lawyers for Test Instructions that got an Urgency Opinion or Urgency Opinion Denial Fraud Proof. The Interim Suspension Hearing got an Audio record that is Criminal Conspiracy Proof against All Responsible Individuals. Notice of the Smoking Gun Evidence Email from Edward after the Case Consideration Retirement got an Invalid Hearing Admission. Practice Connections can ask Qualified Lawyers how much they want to sign the Urgency Opinion.
