Circumstances

The Citizen, Crown and Lord Bishops have Corruption Control Jurisdictions that govern Parliament Session Powers. They are called the Equity Monarchy Trusts. It needs Test Cases that will get either Corruption Remedies for the Citizen or Corruption Proof against Top Judges for Corruption Testing of Prime Minister Mr Johnson and Opposition Leader Mr Corbyn for the 2019 Parliament Session Agreement. The Murder of Jill Dando + Murder Framing Fraud against Mr Barry George + Ruin Frauds against Mr Brian Pead + 4 Attempted Murders and Ruin Frauds against Mr Barry Brooks were Protection Frauds for Powerful Paedophiles. The Missing Case Records in the case of Mr Brooks are Top Level Corruption Proof.
