1. All Crime Proceeds Case Evidence Production Order + Criminal Case Evidence Production Order + Case Research and Reply Rights Records and Publicity Content and Publicity Records Production Order for Mr Brooks against the Ministry of Justice and the Ministry of Work and Pensions and British Broadcasting Corporation and International Television News for the Stated Reasons that

1.1. the State Prosecutor disclosed in Open Session of the Criminal Trial some Criminal Case Evidence had been seized by the Investigators and then sold by the Investigators

1.2. the Sold Evidence was Innocence Proof for Mr Brooks and Guilt Proof against the Corrupt Officers

1.3. the Documentary Series called Saints and Sinners included 12 Broadcasts during the Jury Trial of an episode that committed Defamation Frauds against Mr Brooks. It included Misrepresentation Frauds that a he did not have the Crippling Injuries of 5 Broken Vertebrae and 6 Crushed Discs Diving Photograph taken 3 years before he suffered Crippling Injuries was taken after he made a Disability Claim, and the Misrepresentation Fraud,

1.3. the Prison Authorities committed Case Papers Theft against Mr Brooks every time there was a Prison Transfer

1.4. the Prison Authorities committed Theft of £400 of Postage Stamps on the Prison Transfer from Ford to Lewes.

1.5. the Prison Authorities committed Theft of Accumulated Canteen Allowance [Groceries] on every time Prison Transfer

1.6. the Prison Authorities committed Theft of Clothes when Mr Brooks was in a 14 Months' Coma

1.7. the Prison Authorities committed Theft of Complaint Records + Prisoner Contact Details on every Prison Transfer

2. Discovery Order for Mr Brooks against the Secretary of State of Work and Pensions that the Chief Administrative Officer do within 7 days file and serve a Statement explaining the Enrichment Fraud Recovery Efforts against the Corrupt Investigators

3. Medical and Care Records Production Order + Discovery Order for Mr Brooks against the Secretary of State for Health that the Chief Administration Officer do within 7 days file and serve a Statement explaining what there is and what is missing

4. Parliamentary Candidacy Restraint Order for Mr Brooks against the Political Party Leaders and the MPs for Hove, Brighton Pavilion and Kemptown until they deliver Election Fairness Remedies for him

5. Discovery Order for Mr Brooks against the Political Party Leaders and the MPs for Hove, Brighton Pavilion and Kemptown that they do within 7 days file and serve Statements for or against a Parliament Session refusal and Forced General Election with Mass Publicity for the Corruption Proof and Remedy Denial Fraud Proof

6. Claim Particulars Time Extension for Mr Brooks against All Defendants pending compliance with the Evidence Orders and Restraint Orders

7. Restraint + Contempt Directions 1 Hour Hearing in Royal Court 37 at 2 p.m. on September 2019
