The Practice Patients, Osteopath Ms Davies sand the Parliament Session Jurisdictions need a Rapid Process. The Pharmaceutical Industry bought Market Frauds for Drug Treatment against Non-Drug Treatment. It included the establishment of the General Osteopathic Council. In 2000 Corruption Complaints in more than 200 Parliamentary Constituencies got a Corruption Debate, Investigation Commitment from the Governing Majority and Pending Investigation Adjournment. A Business Deal got 2001 General Election Campaign Finance for Prime Minister Mr Blair, an Investigation Denial Fraud + Corruption Continuity for the General Osteopathic Council.

In 2004 the preparations for the European Constitution Referenda got Election Fraud Conspiracy Proof against the European Leaders. It supported a Corruption Notice to the Crown and Parliament that got Revived Use of the Parliament Session Jurisdictions after a Dormancy Period of 45 years. It got a Forced Resignation from Prime Minister Mr Blair, Dismissal Decisions against Prime Minister Mr Brown and the Labour Governing Majority and use of the Expense Account Scandals in 2009 to enforce it. It got Remedy Co-operation from Prime Minister Mr Cameron, Deputy Prime Minister Mr Clegg and Opposition Leader Mr Miliband. It got a Forced Resignation from Prime Minister Mrs May and a Forced General Election against the Governing Majority. The Session Priority in December 2019 was either Remedy Proof for the Law Courts or Criminal Conspiracy Proof for Dismissal Decisions against Top Judges in Parliament. Integrity Tests Cases got the Criminal Conspiracy Proof. The 2021 Parliament Session Priorities required Responsibility Apportionment between Case Remedies by Law Courts and Mass Remedies by Parliament. Integrity Test Cases got Remedy Unfitness Proof against the Law Courts.

In 2021 a Corruption Complaint by the Claimant did not get a Complaint Process. It got a Conflict Jurisdiction Qualification Fraud + Mental Illness Presumption Fraud + Profession Fitness Investigation Fraud and the 2 Months Interim Suspension Order on 1st October 2021. The Fraud Conspiracy Proof includes a Profession Governance Conflict Qualification Contempt Frauds Claim + Interim Remedy Stay Application Hearing Denial Frauds on 10th and 24th September 2021 by the High Court Queen's Bench Division
