From Citizen Mr Akwasi Nkrumah To Chelmsford Crown Court

Public Gallery Rights Case 2021 0297 Contempt Remedy Hearing Demand for the Stated Reasons:

1. The 2021 Parliament Session Priorities required Responsibility Apportionment between Case Remedies by Law Courts and Mass Remedies by Parliament
2. 11th May 2021 was Parliament Session Opening Day
3. On 12th May 2021 Citizen Mr Nkrumah sat in the Public Gallery in Southend Magistrates Court. He observed a Bald Tyre Motor Case that got an Adjudicator Identification Refusal Fraud that converted Judicial Status into Officer Status. He observed a Temper Tantrum by the Anonymous Officer who left the Court Room through the Judge Chambers Door
4. Event a Public Gallery Clearance Fraud Conspiracy by the Anonymous State Officer and Essex Police to enable a Motor Case Secret Hearing Fraud. It got a Public Gallery Burglary + Kidnapping + Assault Framing Fraud on 12th May 2021 by Essex Police. It got a Case Transfer Fraud to Hertfordshire Magistrates and Committal Fraud to the Crown Court and Jurisdiction Deficit Admission + Contempt Remedy Denial Fraud by Crown Court Judges and a Case Transfer from St Albans to Chelmsford
5. The Criminal Conspiracy Fraud Appeals are:
 - 5.1. Child Trafficking Wardship Claim FD20P00642 to the Court of Appeal,
 - 5.2. Osteopath 2855 Profession Unfitness Case 839 from a Profession Authority to the Queen's Bench Division and Administrative Court will get remedy Orders or Fraud Appeals to the Court of Appeal
 - 5.3. Enforcement Fraud F00LE923 is to get remedies for High Court Frauds from the County Court
 - 5.4. Discharge Fraud HOONR895 is to get remedies for County Court Frauds from the County Court
6. The 2021 0297 Contempt Remedy Hearing Demand is to get an Audio Record that is Fraud Remedy Proof for the Crown Court or Remedy Refusal Fraud Proof against the Crown Court
