Circumstances

Mr Yediayli is a Turkish Immigrant with Limited English and Limited Office Skills and a Business Lease for the Fast-Food Shop at 222 Devons Road, Bow. Top Police and Top Judges have a Crime Partnership. They wanted the Fast-Food Shop for Theft Profits and Money Laundering. They used a Framing Fraud to get a Forced Sale and then Sale Management Frauds to get Premature Possession and Full Payment Denial Fraud with Crime Investigation Denial Frauds by Top Police and Remedy Denial Frauds by Top Judges. The 1st Framing Fraud failed. It used Perjury Immunity Frauds for 3 Women for a Harassment Prosecution Fraud. The Crown Court Judge noticed Innocence Evidence Concealment Frauds, supervised the Lay Jury into an Acquittal Decisions and gave Claim Advice for the Victim against the Metropolitan Police, Ministry of Justice and Defenders. Emotional Exhaustion and Financial Exhaustion and Limited Skills prevented him from acting on the Claim Advice. A 2nd Framing Fraud used Planted Evidence for a Hygiene Regulation Breach Prosecution Fraud that got a Shop Closure Order and Refurbishment Costs and a Forced Sale and Premature Possession and Full Payment Refusal Fraud. The Criminal Complaint got Investigation Denial Fraud Proof for My Yediayli against the Metropolitan Police.

The Citizen, Crown and Lord Bishops have Corruption Control Jurisdictions that govern Parliament Session Powers. They use Contempt Jurisdiction and the Common Law to get Corruption Findings and Remedy Entitlement Findings and Remedy Priority Findings for Dismissal Decisions against Top Officers and Top Judges, and Remedy Failure Findings for Dismissal Decisions against Top Politicians. The Ultimate Sanction is a Parliament Session Refusal and Forced General Election with Mass Publicity for the Corruption Proof and Remedy Denial Fraud Proof. It enables the Imposition of Corruption Remedy Conditions in Parliament Session Agreements between the Crown and Cabinet. In 2004 Fraud Conspiracy Proof against European Leaders revived use of the Parliament Session Jurisdictions after a Dormancy Period of 45 years. A Privilege Waiver and Confidentiality Waiver got Citizen Status for Mr Yediayli with Case Management by Equity Lawyer Mr Ellis. Shop Theft Claims 2019 03741 + 3984 got Original Papers with Stamp Ink + Seal Ink that is Forensic Test Material. Top Judges made a Forensic Test Sabotage Fraud Plan. It used Sale Enforcement Fraud Claim G02EC632 and Defence Lawyers Silvine Law to get the Original Papers. It failed. Land Cases got Fraud Proof for Citizens Mr Hastunc and Mr Serbert against Silvine Law and Law Courts. Health Market Frauds got it for Citizen Osteopath Ms Davies against Profession Authorities and Law Courts.
