Equity Governances uses a Justice Office Jurisdiction Separations and a Neutrality Qualification and a Conflicted Interest Disqualification and Common Processes for Truth Discovery and Just Reasoning. The Dictator Governance Plan needed Jurisdiction Concentrations + Conflict Qualifications + Ruin Fraud Powers for the State against All Professionals. Politicians lost control to Crime Partnerships of State Officers and Law Court Judges and the Protection Fraud Network. It provides Support Services and Corruption Co-ordination. The Parliament Session Jurisdictions managed a Corruption Remedy Process to get Total Destruction of the Protection Fraud Network. The 2021 Session Priorities required Responsibility Apportionment between Case Remedies by Law Courts and Mass Remedies by Parliament. Test Cases got Remedy Unfitness Proof against the Law Courts. The Profession Unfitness Frauds against Citizen Ms Davies got Criminal Conspiracy against the Profession Authorities, Law Courts and GP Dr Harris.
