Public Gallery Rights Case 2021 0297 Contempt Remedy Hearing Demand for the Stated Reasons:

1. The 2021 Parliament Session Priorities required Responsibility Apportionment between Case Remedies by Law Courts and Mass Remedies by Parliament
2. 11th May 2021 was Parliament Session Opening Day. On 12th May 2021 Citizen Mr Nkrumah sat in the Public Gallery in Southend Magistrates Court. He observed a Bald Tyre Motor Case that got an Adjudicator Identification Refusal Fraud that converted Judicial Status into Officer Status. He observed a Temper Tantrum by the Anonymous Officer who left the Court Room through the Judge Chambers Door. Events revealed a Public Gallery Clearance Fraud Conspiracy by the Anonymous State Officer and Essex Police to enable a Motor Case Secret Hearing Fraud. It got a Public Gallery Burglary + Kidnapping + Assault Framing Fraud by Essex Police, then a Case Transfer Fraud to Hertfordshire Magistrates and Crown Court Committal Fraud, then a Jurisdiction Deficit Admission + Wasted Costs Denial Fraud + Contempt Remedy Denial Fraud + Case Transfer Fraud on 31st August 2021 by Crown Court Judges from St Albans to Chelmsford. On 3rd September 2021 it got a Public Gallery Crimes Summons Issue Refusal Fraud + No Case Reasons Fraud by the Essex County Lawyer.
3. The Process Delay Frauds and Process Denial Frauds and Sealed Order Service Denial Frauds are Appeal Sabotage Frauds that prevent Fraud Appeal from the High Court to the Court of Appeal against the FD20P00642 Child Trafficking Protection Frauds and the Profession Governance Frauds. The Security Discharge Fraud HOONR895 and Enforcement Fraud F00LE923 are County Court Fraud Appeals that should get Case Transfers by the County Court to the Court of Appeal.
4. On 7th October 2021 a Confidence Collapse for the Divorce ZC14D02308 Property Fraud Enforcement got 7 Days' Hearing Vacation Notice + 7 ½ Months Available Dates Request from the Family Court
5. The 2021 0297 Contempt Remedy Hearing Demand is to get an Audio Record that is Fraud Remedy Proof for the Crown Court or Remedy Refusal Fraud Proof against the Crown Court
