Upon reading the Contempt Claim Interim Remedy Application

The Circumstances

1. The Subject Data Access Request 210510024 of Mr Zarb got the Response Email at 15.36 on 29th July 2021 from Ministry of Justice Knowledge and Information Liaison Office <LondonKILO@jsutice.gov.uk> that is a Total Denial of Any High Court Case Record between Mr Francis Zarb and Miss Hanifa Neluyima
2. The County Court Enforcement Claim F00LE923 being for a High Court 2018 0239 Appeal Costs Order for Miss Neluyima against Mr Zarb
3. Enforcement Claim F00LE923 Contempt Remedy Proposals dated 6th September 2021 made the Contempt Fraud Case and Hearing Management Proposals. The Royal Commission Service Email at 22.21 that day was Due Notice to the Claimant, County Court and High Court.
4. The Fraud Case got Separate Representation Rights for Ms Neluyima against Lawyer Mr Sowerbutts
5. The Settlement Negotiation Offer by Mr Zarb having got a Negotiation Refusal by Miss Neluyima
6. The Enforcement Claim F00LE923 Hearing Proposals dated 16th September 2021 were an Updated Position Statement with Due Notice by the Royal Commission Email at 14.11 on 17th September 2021
7. The Enforcement Claim F00LE923 Directions Hearing on 20th September 2021 got an Audio Record that is Adjudication Responsibility Proof against Identifiable Individuals
8. The Enforcement Claim F00LE923 Appeal Grounds + Proposals and the Contempt Remedy DRAFT Order both dated 20th September 2021 being Remedy Action Intent Evidence for Citizen Mr Zarb
9. The Enforcement Claim F00LE923 Email Service on 8th October 2021 by Case Manager Mr Sowerbutts of the Witness Statement dated 8th October 2021 of Ms Neluyima being Totally Inconsistent with her having Credibly Independent Representation and it appearing to have a Photocopy Signature Page that raises Forgery Suspicions + Perjury Suspicions against Case Manager Mr Sowerbutts
10. The Enforcement Claim F00LE923 Witness Statement of Case Manager Mr Paul Sowerbutts giving an Appeal Explanation that reveals an Appeal Hearing on 22nd March 2021 before Justice Mrs Stacey got an Appeal Dismissal that is Totally Inconsistent with the Case Record Denials by the High Court that is Contempt Fraud Conspiracy Proof against Case Manager Mr Paul Sowerbutts or Court Officers
11. The Record Denial or Appeal Costs Order are Forgery + Perjury + Contempt Fraud Conspiracy Proof.
12. High Court Justice Mrs Stacey has Fact Witness Status in a Court Fraud Investigation.
13. The Sealed Order Service Denial Fraud Complaint dated 10th October 2021 of Mr Zarb against the High Court and the County Court respectively for the Alleged Appeal Dismissal Order dated 21st March 2021 and the Directions Order dated 20th September 2021 are Delay Explanations for the Contempt Remedy Denial Fraud Appeals to the Court of Appeal and County Court

County Court Eviction Claim D00BT669 Judgment and Trial Costs and High Court 2018 0239 Appeal Costs Enforcement Claim F00LE923 Finding + Appeal Costs Validity Contest Finding + Subject Data Request 210510024 Email Notice of a Total Denial of High Court Appeal 2018 0239 and therefore the Appeal Costs + Appeal Costs Validity Enquiry Entitlement Finding + Validity Enquiry Denial Finding + High Court Judge Entitlement Finding + High Court Judge Denial Finding + Before Trial Settlement Negotiation Offer Finding + Negotiation Refusal Finding + Before Trial Court Motion Remedy Proposals Finding + Court Motion Remedy Failure Finding + Fraud Conspiracy Suspicions Finding Temporary Judge Case Allocation and Judicial Career Blackmail Suspicion Finding + Contempt Investigation Entitlement Finding + Pending Investigation Enforcement Stay Protection Entitlement Finding for Citizen Defendant Mr Zarb against the Claimant Miss Neluyima for the Stated Reasons that:
 - 1.1. The Corruption Remedy Priorities for the 2021 Parliament Session required Responsibility Apportionment between Case Remedies by Law Courts and Mass Remedies by Parliament
 - 1.2. Between Parliament Session Opening Day on 11th May 2021 and the Summer Recess a series of Test Cases got Remedy Unfitness Proof against the Law Courts. It increased the Mass Remedy Obligation of Parliament
 - 1.3. The Eviction Claim D00BT669 and Enforcement Claim F00LE923 in the County Court and Trial Costs and Fraud Appeal 2018 0239 in the High Court provided Identical Facts for Test Cases that will get Remedy Proof for the Law Courts or Remedy Denial Fraud against them and either Sealed Orders for Fraud Appeal Tests to the Court of Appeal or Sealed Order Denial Fraud Proof that is Supervision Fraud Proof against the Court of Appeal.
