Stated Reasons

1. Since 2004 a series of Top-Level Corruption Investigations for the Parliament Session Jurisdictions discovered Crime Partnerships of State Officers and Adjudication Officers managed Systematic Corruption at every stage of the Justice Process. A Protection Fraud Network provided Support Services and Corruption Co-ordination. They sold Market Frauds to Organised Crime, provided Protection Frauds for Corrupt Officers who managed them and traded Glittering Career Guarantees and Job Profits in exchange for Fraud Services by Corrupt Parliamentarians.
2. Systematic Corruption includes:
 - 2.1. Corrupt Processes
 - 2.2. Appointment Frauds for Incompetent Officers and Corrupt Officers to manage the Corrupt Processes
 - 2.3. Old Building Works Frauds that installed Public Gallery Cages placed to get Unusable Front Seats that were Facility Reduction Frauds against the Public Gallery Witness.
 - 2.4. Old Building Works Frauds that installed Dock Cages that enabled
 - 2.5. Dock Entry Requirement Frauds + Inequality Frauds against the Citizen and Party Access Denial Frauds against the Public Gallery Witness
 - 2.6. New Building Design Frauds for Canterbury Courts included
 - 2.6.1. Court Process Observation Sabotage Fraud against the Citizen using an Unfit Public Gallery in a Crown Court.

7. The Corruption Remedy Process of the Parliament Session Jurisdictions forced the Behaviour Cycle from Victory Dance Fraud Boasts and got Remedy Belief that got Protection Frauds Demands for Corrupt Officers against Law Court Judges and then got a Confidence Collapse and Furtive Frauds by Top Judges.
8. The 2021 Parliament Session Priorities required Remedy Deliveries. It needed Responsibility Apportionment between Case Remedies by Law Courts and Mass Remedies by Parliament. Between Session Opening Day on 11th May 2021 and the Summer Recess a series of Test Cases increased the Confidence Collapse for Fraud Completion by Law Court Judges and got Remedy Denial Fraud Proof against them. It increased the Mass Remedy Obligation of Parliament.
9. The Remedy Process needed Publicity Management.
10. Top Politicians used a Judicial Enquiry into everything that enabled use of Police Office + Police Resources for Rape + Murder. They did it for Publicity Purposes.
11. Top Politicians knew that the European Constitution vested Dictator Powers in the State. The Politicians lost control to Crime Partnerships of State Officers and Law Court Judges and the Protection Fraud Network. They need the Citizen to use Corruption Cases and the Common Law to get Remedy Proof for the Authorities or Remedy Denial Fraud Proof for use by the Higher Authorities. The Proof Sets got by the Corruption Cases are Admissible Evidence for the Judicial Enquiry.

The Enforcement Claim Fraud F00LE923 includes a High Court Fraud Appeal 2018 0239 Costs Order and a High Court Subject Data Request Response that is a Total Denial that the 2018 0239 or Any Other Record is a Case Record of the Parties. The Costs Order or the Records Denial is Record Fraud Conspiracy Proof against the Enforcement Claimant and the Law Courts. According the Audit Reports from when the Labour Governing Majority got office in 1997 until they lost it in 2010, they made £1,000,000 Per Day Write Offs. They used Computer System Development for Budget Frauds to finance Top Level Corruption. In the early stages the Contractors used Obvious Design Frauds as Commitment Tests of the Contract Awarders. They used an NHS Contract for a Fraud Commitment Test. They used a Failure Unsafe Central System Design instead of a Fail-Safe Distributed System for the Fraud commitment Test They needed Fitness Tests to get Corrupt Teams for the Corrupt Contracts and Honest Teams for Honest Contracts and Market Frauds against anyone who was a Corruption Exposure Risk. Mr Zarb was Technically Competent but Politically Naïve. He did not realise that the Obvious Design Fault was a Corrupt Team Fitness Test. Honest Advice from him got Fraud Exposure Risk Status + State Market Exclusion Frauds against him. A Reuters Contract got Global Corporate Market Exclusion Frauds against him. A European Referenda Commitment in the 2015 General Election Campaign got a Governing Majority for Prime Minister Mr Cameron. The Session Priorities got Set Up Conditions for Corruption Dismissal Cases against Top Judges. Prime Minister Mr Cameron could not manage the Remedy Process and Dismissal Cases against Top Judges at the same time. He made a Priority Decision for the European Referenda because the Judge Dismissals would expose Industrial Scale Corruption and increase the Leave Votes. He led the Remain Campaign, lost and resigned. The Protection Fraud Network needed Protection Frauds from his successor. They bought Leadership Votes for MP Mrs May because she was one of them. She required New Frauds as Commitment Proof from All Receivers before the Protection Fraud Supply. The New Frauds from the Budget Fraud + Bribery Managers included use of a Lodger Frauds to get Eviction Claim Fraud D00BT669 + Trial Frauds + Judgment + £9,600 Damage Frauds + £50,000 Costs Frauds. It got the Fraud Appeal 2018 0239 by the Victim. The Citizen discovered the Parliament Session Jurisdictions and gave use of the case to the Parliament Session Jurisdictions. as a Comparator Case for the Case Management of Counsel and the Equity Lawyer. A Land Fraud Conspiracy needed many Thousand Tenancy Forgeries by Housing Association Officers as Fraud Commitment Proof to get Protection Fraud Supplies from Top Judges.
