The Circumstances

The Politicians agreed the European Constitution. It vested Dictator Powers in the State. In every Member State of the European Union the Politicians lost control to Crime Partnerships of State Officers and Law Court Judges. They developed Protection Fraud Networks to provide Support Services and Corruption Coordination. They sold Market Frauds to Organised Crime, provided Protection frauds for the Corrupt Officers who managed them and traded Glittering Career Guarantees and Job Profits in exchange for Fraud Services by Corrupt Parliamentarians. General Elections got Governing Majorities that were subject to Remedy Denial fraud Majorities controlled by the Protection Fraud Networks.

The Pharmaceutical Industry bought Market Frauds for Drug Treatment against Other Treatment. They used Profession Authority Legislation Frauds to get Market Frauds by the General Osteopathic Council against the Osteopath Profession. In 2000, Corruption Complaints in more than 200 Constituencies got a Corruption debate + Investigation Commitment + Pending Investigation Adjournment. A Business Deal got 2001 General Election Campaign Finance from the Pharmaceutical Industry for Prime Minister Mr Blair and Investigation Denial Frauds + Corruption Continuity for the General Osteopathic Council. The Market Frauds against the Osteopath Profession progressed to Service Satisfaction Publicity Restraint Frauds. Publicity Restraint Enforcement got Corruption Findings + Remedy Initiative Decision by Osteopath 2855 Ms Davies against the General Osteopathic Council.

The Protection Fraud Network used Case Management Frauds against Corruption Victims. One of them used Internet Trolls and Provocation Agents for Case Management Advice Frauds for False Jurisdiction Claims and Without Trial Liability Declarations. Corruption Complaints got Lunatic Litigation Evidence against the Advice Fraud Victims that supported Protection Frauds for Corrupt Officers.

Honourable Politicians needed Corruption Remedy Powers for the Citizen against the State. The United Kingdom Constitution vested Corruption Remedy Powers in the Citizen. The Coronation Oath is for Equity Governance using the Common Law. The Glorious Revolution of 1687 - 1689 established the Coronation Oath Enforcement Authority. The Citizen has Investigation Jurisdiction. The Crown has Prosecution Jurisdiction. It is the power to issue Trial Orders for Corruption Cases against the State and Unfitness Cases against Officers and Authorities. The Lord Archbishops have Court Lawyer Jurisdiction, one for the Trial Court and the other for the Appeal Court. The Lord Bishops have Adjudication Jurisdiction. There are 24 of them so that up to 12 sit as Trial Jurors and up to 12 others sit as Appeal Jurors. They use the Corruption proof Remedy Standard. It is Official records that are Justice Proof for Honourable Officers or Guilt Proof against Corrupt Officers and Credibility Irrelevance Proof for the Victim. Corruption Proof gets Corruption Findings + Remedy Entitlement Findings + Remedy Priority Findings for the People and an Execution Responsibility Finding against one or more Cabinet Officers. A Remedy Success is Justice Proof for the Relevant Officers. A Remedy Failure gets an Unfitness Case + Remedy Failure Finding + Dismissal Priority Finding + Execution Responsibility Finding against the Relevant Authority. The Ultimate Sanction is Dismissal Decision against a Governing Majority managed by a Parliament Session Refusal + Forced General Election + Mass Publicity for Corruption Proof + Remedy Denial Fraud Proof. It enables the imposition of Corruption remedy Conditions in Parliament Session Agreements between the Crown and Prime Minister. Case Management Sabotage Frauds by Dictator Politicians against the Citizen denied a Reliable Supply of Admissible Evidence for Parliament Session Decisions. It got a Dormancy Period for the Coronation Oath Enforcement Authority. Citizens made an Equity Governance Recovery Plan. It needed Corruption Proof against a Prime Minister to support a Corruption Notice to the Crown and Parliament, end the Dormancy Period, and revive use of the Coronation Oath Enforcement Authority. In 2004 the preparation for the European Referenda got Election Fraud Conspiracy Proof against the European Leaders including Prime Minister Mr Blair. They wanted Blackmail Fraud Powers for the State against the Citizen using Electronic Signature Dictator Powers. They wanted to make Immediate Obedience Demands with Financial Asset Access Denial Threats using Electronic Signature Dictator Powers. Full Disclosure would get a choice between Dictator Powers for the State and Financial Asset Access for the Voters and a

Landslide Rejection of the European Constitution. They used Extradition Frauds + Imprisonment Frauds to prevent exposure of the Election Frauds. The Extradition Fraud Deal required Innocence Evidence Concealment Frauds by the British Authorities before completion of the Imprisonment Frauds by the Dutch Authorities. Innocence Evidence Concealment Fraud Proof got Dismissal Decisions against Law Court Judges and an Execution Responsibility Decision against Prime Minister Mr Blair

Ms Davies had Case Management Capacity for the Corruption Finding + Remedy Initiative Decision but not for an Advice Fraud Finding against Internet Trolls + Provocation Agents. In October 2020 an Email Introduction for her to the Equity Lawyer did not get Case Management Advice from him. The Remedy Process needed him to get Criminal Conspiracy Proof for Dismissal Cases against Top Judges. The Osteopath Corruption Case was unlikely to get it in time for the 2021 Parliament Session Decisions. She did not get Entrapment Fraud Warnings or Case Management Advice. She relied on the Advice Frauds. A Corruption Complaint got a Complaint Acknowledgement + Complaint Process Conflict Qualification Fraud + Dismissal Fraud by the General Osteopathic Council for itself against Ms Davies. The Conflict Qualification Fraud continued with a Mental Illness Presumption Fraud + Mental Fitness Investigation Fraud + Medical Records Access Consent Demand Fraud + Mental Examination Consent Demand Fraud. They got Conflict Disqualification Notices + Action Intent Notice. It got Repeat Consent Demand Frauds by them and a Blackmail Fraud Extortion Notice Addition to the Consent Form from her. Profession Guidance Request Advice + Delusion Proof Demand Advice + Patient Access Refusal Notice + GP Medical Profession Unfitness Complaint Warnings + Settlement Negotiation Offers + Complaint Meeting Offers from the Citizen and from the Equity Lawyer to the GP Harris got Advice Rejection + Warning Rejection + Complaint Process Conflict Qualification Frauds + Complaint Dismissal Frauds + Personal Access Harassment Frauds by the Practice Manager + GP. The Only Credible Explanation is Complete Confidence in Remedy Denial Protection Frauds by the NHS Ombudsman + General Medical Council + West Mercia Police Motive and Criminal Intent to aid and abet Mental Health Frauds + Profession Disqualification Frauds.
