### Without Prejudice to Invalidity Arguments

#### Corruption Remedy Case Notice for the Coronation Oath Enforcement Authority

On 5<sup>th</sup> November 2021 Filing of the Court Fraud Remedy Claim vested the Conflict Jurisdiction for the Cases Series in the Superior Jurisdiction of the Chancery Division of the High Court. It got a Remedy Only Jurisdiction Limit for Citizen Mr Hastunc against Eatsnow Estates Limit and the Inferior Jurisdictions of the State and County Court. The Limited English Language and Corruption Case Management Incapacity of Citizen Mr Hastunc resulted in an 11 Day Service Delay of Appeal Papers. On 17<sup>th</sup> November 2021 the Cyprus Gardens Eviction Event got Possession Fraud Commitment Proof against the Landlord, Representative, Bailiff and Metropolitan Police until a Confidence Collapse by the Bailiff stopped it. Equity Lawyer Mr Ellis provided Co-ordinated Case Management for the Remedy Process Cases. The Remedy Process needed Case Management Tests of the Investigators, Prosecutors, Defenders, Trial Adjudicators and Appeal Adjudicators. Culture Conditioning results in Dependency Differences for Anglo Saxons and Legal Immigrants. The Equity Governance Legacy results a Time Lag for the Anglo Saxons between the discovery of Fraud Conspiracy Proof against Qualified Lawyers and the Emotional Acceptance needed for Effective Remedies. In many cases the Emotional Acceptance comes too late. The Political Governance Legacy elsewhere results the Time Lag for Legal Immigrants being shorter with Emotional Acceptance in time for Effective Remedies provided they can find a Case Manager. It resulted in Corruption Cases of 4 Legal Immigrants from Turkey and Cyprus having Best Qualification for the Defender Tests. They were Citizens Mr Ediz Hastunc, Mr Can Say, Mr Ali Serbet and Mr Bayram Yediyali. Citizen Mr Can Say had the More Varied Business Experience than the others Better English. He provided Emotional Support Services and Amateur Interpreter Services. Ill Health compromised his ability to do so. In spite of that the Shop Theft Cases 2019 0003741 + 003984 of Citizen Mr Yediyali and Cyprus Gardens Lease Claim Fraud F02ED793 against Citizen Mr Hastunc got Fraud Conspiracy Proof against the High Court and County Court. Case 2019 003741 got 2 Backdated Forged Orders. The Seal Ink was Original Record Proof and Forensic Test Material. Top Judges made a Forensic Test Sabotage Fraud Plan. It used a Jurisdiction Frauds, Misrepresentation Frauds and Non-Disclosure Frauds to get issue in the County Court of Enforcement Fraud G00EC632, use Short Notice of a Specific Performance Application Hearing to force Citizen Mr Yediyali to give Representation Instructions to Qualified Lawyers, use them to get Physical Possession of the Cases Papers, service the Sabotage fraud with either Evidence Destruction or Forgery Substitution, manage Adjournment Frauds to deny any Audio Record Proof of the Hearing Frauds and use Blackmail Frauds to get a Settlement Fraud. It failed. Citizen Mr Say found Silvine Law for the Defence Tests. The Short Notice got a Case Reference to the Equity Lawyer that enabled Instruction Tests that got Fraud Conspiracy Proof against the Claimant., Prosecutors, Defenders, County Court and High Court. The Ill Health of Citizen Mr Say got Interrupted Co-operation from the Citizens. Other Cases got Issue Denial Fraud Proof against the High Court. On 5<sup>th</sup> November 2021 the Chancery Court issued Fraud Remedy Claim 2021 000238. On 9<sup>th</sup> November 2021 G02EC632 got a Case Reference to the High County to reopen Case 2019 003741.
