Brief Statement of the 2021 Parliament Session Remedy Priority Test Cases

Reserved Rights for an Extended Explanation and presentation of the Case Records

2004 Preparations for the European Referenda got Election Fraud Conspiracy Proof against European Leaders including Prime Minister Mr Blair. Equity Lawyer Mr Edward William Ellis used it for a Corruption Notice to the Crown and Parliament. It revived use of the Coronation Oath Enforcement Authority and ended a Dormancy Period that had lasted 45 years. It started a Corruption Remedy Process that has continued ever since. At the start few understood it. Gradually more did.

Pending Superior Jurisdiction Adjudication Enforcement Stay Protection Rights from the Crown and Parliament for Citizens against the Cabinet enable use of their cases for Session Priority Performance Tests +Superior Jurisdiction Protection Tests of the State, Profession Authorities, Law Courts, Cabinet and Parliament.

Parliament Session Priorities include Legal Service Crime Prosecution Prohibitions and Civil Contempt Enforcement Prohibitions for Equity Lawyers against the Cabinet. It enables them to provide Investigation Services for the Coronation Oath Enforcement Authority by recruiting Citizens, and providing Case Management Services that got Proof

Sets that met the Corruption Remedy Proof Standard. It motivates Corrupt Officers to demand Protection Frauds that need use of the Contempt Powers of the Law Courts against the Equity Lawyers with Top Judges signing Every Major Decision.

The Equity Lawyer managed a series of Parliament Session Priority Tests that got Corruption Proof and Remedy Denial Fraud Proof. They were used for Corruption Findings and Dismissal Decisions against Prime Minister Mr Blair using a Forced Retirement Notice and against Prime Minister Mr Brown and the Labour Governing Majority using Expense Account Scandals timed to coincide with the 2009 Election Campaign Period

2010 Corruption Investigations of the State, Profession Authorities and Law Courts get the information needed for Systematic Destruction of the Protection Fraud Network. The

2015 Remedy Process gets Confidence Collapses and Fraud Completion Refusals by Low Ranks that forces Fraud Completion Decisions up the Command Chains to the High Ranks

2015 The Parliament Session Priority is Corruption Findings + Unfitness Cases + Dismissal Decisions against Top Judges in Parliament. It requires a Fraud Invalidity Precedent [Sharland v Sharland] + a Conflict Disqualification Precedent [Emerald Supplies v British Airways] + Claim Issue Rights for the Citizen against the Law Courts. It enables the Filing of Fraud Claims forces Corrupt Officers to choose between making Conflict Disqualification Admissions and committing Conflict Qualification Frauds to get the Case Control needed for Issue Denial Frauds + Dismissal Frauds + Restraint Frauds against the Citizen. It makes Official records the Conflict Qualification Fraud Proof and Conflict Qualification Frauds the easiest crime for the Citizen to prove.

A European referenda Commitment got a Governing Majority for Prime Minister Mr Cameron. He cannot manage the European Referenda and Top Judge Dismissals at the same time. He makes a Priority Decision for the European Referenda to avoid the Corruption Exposure of the Top Judge Dismissals increasing the Leave Vote.

The Equity Lawyer recruits Citizens and manages Session Priority Tests that got Criminal Conspiracy Proof for Unfitness Cases against Top Judges. The Case Management of Victims who know nothing about the Coronation Oath Enforcement Authority and the Corruption Remedy Process provide Case Management Comparators for the Session Priority Test Cases

2015 A Protection Fraud Deal used many thousand Tenancy Forgeries by Housing Association Officers as Fraud Commitment Proof to get Protection Fraud Supplies from Top Judges

The Record Frauds include a Forged Appeal to get an Appeal Dismissal Fraud by Crown Court Judges. A Genuine Appeal discovered the Appeal Frauds. They were Comparator Cases for the Session Priority Test Cases.

2016 Trust Asset Sale Claim Fraud B01B0837 by Trustee Son Mr Vishal Sood v Beneficiary  
+++ Father Mr Sham Sood gets a High-Risk Classification by Low Rank Judges because they know Top Judges use Financial Service Agents as Target Trustee Sons is a Financial Services Agents as Asset Theft Target Spotters and the Trust Son is a Financial Service Agent. It gets Fraud Services + Fraud Completion Refusals by Low Rank Judges. They were Comparator Cases for the Session Priority Test Cases.

2016 European Referenda Leave Majority + Honourable Resignation of Prime Minister Mr Cameron + Leadership Contest + Protection Fraud Network need to stop the Top Judge Dismissal Frauds and buy Leadership Votes for MP Mrs May because she is one of them + 5-year delay for the Top Judge Dismissals.

2016 The Equity Lawyer

2016 A Fast – Food Shop Theft Conspiracy used Perjury Immunity Frauds for 3 Women Witnesses by the Metropolitan Police to get a Harassment Framing Fraud against Owner Mr Yediayli. The intent was to get a Forced Sale and then use Sale Representations Frauds to get Premature Possession and Sale Price Payment Denial Frauds and Theft Completion with Remedy denial frauds by the State and Law Courts. It failed. The Trial Judge noticed Innocence Evidence Concealment Frauds, supervised the Jury into an Acquittal Decision and gave Claim Advice for the Victim against the Metropolitan Police, Ministry of Justice and Defenders. A 2<sup>nd</sup> Framing Fraud for Hygiene Regulation Breaches got the Forced Sale + Shop Theft

2017 The Equity Lawyer managed a series of Parliament Session Priority Test Cases that get Criminal Conspiracy Proof against Top State Officers and Law Court Judges. The Coronation Oath Enforcement Authority used it to decide the 2017 Parliament Session Priority. It was a Long Session of 2 ½ years to enable completion of Corruption Investigations of the Law Courts to get Criminal Conspiracy Proof for Unfitness Cases against Top Judges, and use them for Protection Fraud Investigations in Parliament. Prime Minister Mrs May called a Surprise General Election to avoid a Parliament Session Refusal and Forced General Election with Mass Publicity for Corruption Proof + Remedy Denial Fraud Proof.
