## Representations

The 2021 Parliament Session Priority is Remedy Deliveries. It needed Responsibility Apportionment between Case Remedies by Law Courts and Mass Remedies by Parliament. A series of Tests Cases got Remedy Denial Fraud Conspiracy Proof against the State, Profession Authorities, Law Courts, Cabinet and Parliament. The Father Beneficiary is a 1st Generation Immigrant with Limited Education and Limited English and Trust Management Incapacity and Litigation Contest Incapacity. He established a Family Trusts with his two older sons as Estate Trustees. Both of them had Financial Service Qualifications. They gathered Asset Information about Wealthy Clients and sold it to Top Judges for Ruin Frauds. Both of them cheated the Father Beneficiary. Both expected Protection Frauds from the Law Courts. The 2<sup>nd</sup> Son had used Trust Assets for Mortgage Increases for his Personal Benefit. The Youngest Son, Mr Aman Sood, was in Human Resources, a Loyal Son and was willing to act as Replacement Trustee. The 2<sup>nd</sup> Son needed to avoid a Trustee Replacement and Trust Accounting. He did not know the Fraud Market Protocol requires Qualified Lawyers to manage Court Frauds. Everything that could go wrong for the Trustee Son and the Top Judge did go wrong. The Sale Fraud Claim B01B0837 got Case Management by the Trustee Son, then Qualified Lawyers and then the Trustee Son. It coincided the preparations of the Coronation Oath Enforcement Authority for Dismissal Cases against Top Judges in Parliament. The Trust Beneficiary had a Care Duty Entitlement against the Trustee, Trustee Representatives, Beneficiary Representatives and Law Courts. The case got Fraud Conspiracy Proof against all of them. The Settlement Directions did not use Trustee Replacement Powers and Refinance Powers but instead Sale Powers for Unnecessary Sales with Unnecessary Costs and Capital Tax Disposal Liability. Every Hearing Event got an Audio Record and Court Order. All of them are Fraud Conspiracy Proof against Top Judges.
