The Protection Fraud Market is a Confidence Trick. It needs a Credibility Monopoly. The Corruption Remedy Process managed a series of Confidence Collapses that destroyed it. The Protection Fraud Network did not have a Coping Method.

In 2004 Extradition Frauds discovered that Top Police, Top Customs and Top Judges were the Top Drug Dealers. Prime Minister Mr Blair traded Protection Frauds for a Profit Stare. They made a Career Sabotage Fraud Plan against Honest Officers. It needed a Constant Supply of Good Quality Drugs that had a Known History and were Chemically Traceable. It needed Good Quality Water for a Drug Production Business. Sussex had it. The Production Manager and Police Officers wanted Protection Frauds that would last their lifetimes. In 2002 a Firearms Theft got Firearms Corruption Proof. They expected it to get Protection Frauds that lasted their lifetimes.

Career Deals with the Protection Fraud Network got office from 2008 to 2013 as Director of Public Prosecutions for Mr Keir Starmer. In January 2009 the Firearms Theft Victim got the Firearms Corruption Proof Set. It enabled the Corruption Remedy Process to get Criminal Conspiracy Proof against State Officers and Law Court Judges. Mr Keir Starmer was one of the State Officers.

In 2016 the European Referenda got a Leave Majority and an Honourable Resignation by Prime Minister Mr Cameron. The Protection fraud Network bought Leadership Votes for MP Mrs May because she was one of them. In 2019 Corruption Proof got a Forced Resignation from Prime Minister Mrs May and a Leadership Contest. Protection Fraud Trades got Leadership Support Votes and a Contest Win for MP Mr Johnson. It crippled him. He lost the Political Agility to cope with Confidence Collapses got by the Remedy Process. The 2019 Election Defeat got an Opposition Minority and a Leadership Contest for the Labour Party. The Protection Fraud Network needed Protection Frauds by the Opposition Leader. MP Sir Kier Starmer was Best Qualified and a Self-Defence Motive. In 2021 a series of Confidence Collapses got Claim Issue denial Frauds by the High Court and then Conflict Qualification Fraud Conspiracy Claim H00WR692 by the County Court.
