

Royal Commission + Without Prejudice to Invalidity Arguments Filing Event Report 12th January 2022

The Conflict Qualification Fraud Conspiracy Contempt Remedy Claim Filing Event on 21st November 2021 got use of the Claim Form for Claim Issue that got Case Reference H00WR692. The Claim Form Filing Order + Claim Particulars Filing Order + 38 Day Time Limit + Filing Default Strike Out Penalty Order dated 10th December 2021 with Day 11 Print Date allegedly of Deputy District Judge Mitchell.

The Directions Order is a Record Fraud by the Law Court against Citizen Davies, the Coronation Oath Enforcement Authority and the People.

Fraud Proof on anything gets Proof Burden Reversal for the Victim against the Fraud Manager, which is the County Court, and the Fraud Beneficiaries, which are the 7 Defendants.

The Directions Fraud validates a Claim Deterrent Intimidation Fraud Presumption for Citizen Ms Davies that is subject to a Rebuttal Proof. In the circumstances it is an Impossible Rebuttal Burden.

The Intimidation Fraud failed. Case Management Response of the Citizen is a Directions Fraud Appeal and Filing Compliance made Without Prejudice to Invalidity Arguments.

On 12th January 2022 the Filing Attendance by Citizen Ms |Davies got a Building Access Refusal by the Security Officer. Polite Exchanges got a No Known Judge Mitchell Comment by the Security Officer and then Building Access for Citizen Ms Davies. It got access to Court Officer Ms Courtney Blakemore who gave Email Receipt at 11.30 that read ‘ Good morning, Thank you for providing your documentation. We have received this and will update your file accordingly.’

A Case Identification + Document Identification Request Email from Citizen Ms Davies got the Email Receipt at 11.48 that read ‘Good morning, I can confirm there are 8 copies of 9 documents enclosed in the delivery this morning in regards to case H00WR692 and your file has been updated.’
