Formal Demand that the MP do procure Witness Protection from Parliament to create Safe Conditions for Citizen Ms Asha Ekila to give evidence to the Judicial Enquiry into use of Police Office and Police Resources for Rape + Murder.

Witness Intimidation Fraud Conspiracy Complaint by Citizen Ms Asha Ekila that the Investigators, Prosecutors, Defenders, Court Officers, Asset Freezing 012002024660 + 1705133 Case Judges, 2020 7291 Trial Judges and 2020 7291 Re-Trial Judges used Asset Freezing Frauds and Asset Forfeiture Frauds for Intimidation Frauds against her when she was a Defence Witnesses.


At all material times since the Criminal Investigation started it has been obvious that Citizen Ms Asha Ekila had Defence Witness in what is now Crime Retrial 2020 7219. The Criminal Investigation included Asset Seizure + Asset Freezing Orders for the State against Citizen Ms Asha Ekila. The 2020 7219 Jury Trial did not get an Acquittal Decision. It got a Retrial Order.

The Coronation Oath is for Equity Governance using the Common Law. The Citizen, Crown and Lord Bishops are the Coronation Oath Enforcement Authority. Generals Elections change the Governing Majority. The Coronation Oath Enforcement Authority decide the Corruption Remedy Priorities for each Parliament Session.

The 2021 Session Priority is Remedy Deliveries. It needed Responsibility Apportionment between Case Remedies by Law Courts and Mass Remedies by Parliament. Citizens used their cases for Session Priority Tests. They got Remedy Unfitness Proof against the State, Profession Authorities, Law Courts, Cabinet and Parliament. In the spring of 2021 Citizen Ms Ekila discovered the Coronation Oath Enforcement Authority. She allowed use of the Asset Forfeiture Cases for Session Priority Tests. It got a Confidence Collapse and an Asset Release Decision by some of the Asset Case Officers and a Release Sabotage Fraud by other Asset Release Officers and Case Communications Responsibility for a Senior Police Officer. The Proof Positive is a Bank Account Release Court Order for Citizen Ms Asha Ekila that gives the Bank Account Details of her Mother. It got Correction Refusals by State Officers and Law Courts.

On Wednesday 12<sup>th</sup> January 2022 Citizen Ms Asha Ekila attended Snaresbrook Crown Court and was called as a Defence Witness. She did not have the confidence to tell the Jury about the Witness Intimidation Frauds.

Formal Notice that the Judicial Enquiry has a duty to investigate whether the Criminal 2016 0798 Trial + Re-Trial of the Citizen Mr Andrew Taylor got Defence Witness Status for Citizen Ms Monica Linton and used Asset Seizure Frauds + Asset Forfeiture Frauds + Witness Intimidation Frauds against her.
