

The 2021 Parliament Session Tests got Remedy Denial Fraud Proof against the State, Profession Authorities, Law Courts, Cabinet, Prime Minister Mr Johnson, and Parliament. It validates an Unfitness Finding + Dismissal Decision against Prime Minister Mr Johnson. It got Officer Replacement Investigations by the Coronation Oath Enforcement Authority. It needed a Remedy Commitment from the Governing Majority or Opposition Minority. The Credibility Test of the Governing Majority is a Leadership Contest that gets a Credible Leader. A Remedy Commitment by the Opposition Minority has a Credibility Presumption that is subject to Rebuttal Proof. The Incredibility Rebuttal Proof against Opposition Leader Sir Keir Starmer is overwhelming.

The 2010 Parliament Session Priority was a Corruption Investigation of the Law Courts by the Lord Chancellor for the Crown. It got Full Co-operation from Opposition Leader Mr Miliband, Deputy Prime Minister Mr Clegg and Prime Minister Mr Cameron. The fact they did not know the Investigation details eliminated them from suspicion if anything went wrong.

In 2011 The Corruption Investigation used a Firearms Corruption Proof Set, a Witness Protection Denial Fraud Proof Set, a Case Reference by the Queen to the Secret Service and a Case Reference from the Secret Service to Sussex Police Chief Constable. The choice was a Corruption Investigation with Witness Protection or a Firearms Crime Framing Fraud against the Witness as a Protection Fraud for Corrupt Officers. The Chief Constable chose the Framing Fraud. He procured a Prosecution Fraud by the Director of Public Prosecutions, who was Mr Keir Starmer. The Firearms Case was used to get a Document Filing Receipt Service from Sussex Crown Prosecutors for the Parliament Session File kept by the Director of Public Prosecutions for the Prime Minister. The Receipt Stamp Service lasted from December 2011 to November 2019. Parliament Session File Requests from the Crown via the Prime Minister got File Production by the Director of Public Prosecutions. Mr Keir Starmer held that office until 2013.

The Officer Replacement Investigation needs Remedy Co-operation from Opposition Leader Sir Keir Starmer for the Firearms Framing Fraud Victim. Then it needs a Credibility Finding by the Coronation Oath Enforcement Authority for a Remedy Co-operation Commitment by him or an Opposition Leadership Change.

The Corruption Remedy Process used MP Email Address Lists provided by the House of Commons until MP Sir Lindsay Hoyle took office as Speaker. The Address List provided by him got 122 Bounce Messages from Old Email Addresses. The Knighthood Fitness Enquiry Motion Requests and the Corruption Complaints + Parliament Protection Procurement Demands will get Due Notice Findings against the Addressee MPs. They will get a Notice Presumption Findings against All Other MP subject to Rebuttal Proof. It is Relevant Evidence when deciding management of a Forced General Election.
