Attachment Concealment Fraud that denied the Sealed Appellant Notice and Issue Notice from the Forward Email at 11.05 on 20th January 2022 from Citizen Father Beneficiary Mr Sood to the Equity Lawyer but, after Crime Discovery Emails + Telephone Calls did not deny it from the Forward Email at 15.27 on 21st January 2022 from Citizen Father Beneficiary Mr Sood to the Equity Lawyer

Circumstances

1. The 2021 Parliament Session Priority is Remedy Deliveries. Session Priority Test Cases got Remedy Denial Fraud Proof against the State, Profession Authorities, Law Courts, Cabinet and Parliament.
2. The Trust Asset Sale Claim Fraud B01B0637 got Order Breach Contempt Proof for the Citizen Father Beneficiary and Coronation Oath Enforcement Authority against the Trustee Son, Representatives and Mortgagee and Claim Fraud B01B0637 + Fraud Appeal 2020 000968 + 2020 000742 got Contempt Immunity Fraud Proof against the County Court, High Court and Court of Appeal. The Mortgage Possession Claim F01PP7696 got Mortgage Repayment Denial Fraud Proof for the Citizen Father Beneficiary and Coronation Oath Enforcement Authority against the Bank of Scotland, Representatives, County Court and High Court. The Sale Negligence Settlement Breach Claim got Settlement Damages Denial Fraud Conspiracy Proof for the Citizen Father Beneficiary and Coronation Oath Enforcement Authority against Liable

Lawyer Mr Ross Coates, Another Trustee Son and the County Court. The Law Courts use Case Issue Denial Frauds and Case Record Frauds to provide Anonymity Frauds and Case Misrepresentation Frauds as Protection Frauds for Liable Individuals. All three cases were managed to get Hearing Audio Records that are Personal Responsibility Proof against Identifiable Individuals. On 1st June 2021 the Trust Claim Fraud Hearing got an Adjournment Order for a No Case Records Reason because of a Records production Failure by the Court Office. Also, it got Hearing Priority for the Contempt Remedy Application of the Citizen Father Beneficiary against the Possession Enforcement Fraud + Civil Restraint Fraud Applications of the Trustee Son. It got an Adjourned Hearing Notice for 17th December 2022.

3. The Equity Lawyer has Kidney Failure. Dialysis Treatment removes most of the Body Toxins including Surplus Fluids. It does not remove all toxins. It got a Records Production Failure Representation, Hearing Priority Reversal Fraud + Flat Possession Enforcement Fraud + Contempt Remedy Application Adjournment by Judge Lethem for the Trustee Son against the Beneficiary Father.
5. The Law Courts use Order Service Delay Frauds and Denial Frauds for Appeal Sabotage Frauds. The Equity Lawyer produced the Fraud Appeal Grounds dated 27th December 2021 and asked Citizen Ms Berry to assist Citizen Mr Sood in getting Fee Remission. She used Forward Emails as Progress Notices.
6. The Court Order has Print Date 21st December 2021 and Service Receipt Date of 31st December 2021. The Equity Lawyer produced the Contempt Remedy Application Papers and improved the Fraud Appeal Papers. On 6th January 2021 Track and Trace Postal Filing got a Royal Court Post Room Receipt at 7.49 on 10th January 2022 and the Issue Denial Fraud + Appeal Period Expiry Notice + Papers Return on 12th January 2022 and the Issue Notice Email on 13th January 2022 to the Citizen Father and the Sealed Appellant Notice + Issue Notice Service Email to Filing Agent Ms Berry. The Forward Email from her to the Equity Lawyer got the Email Fraud Evidence. The Issue Refusal Notice got the Chronology Investigation + Fraud Proof.
