Take Notice that the Theodorou Family Cases will be used to set Deterrent Penalty Precedents for Child
Trafficking + Budget Frauds + Money Laundering + Immunity Frauds.

The Top UK Corruption Controls are the Coronation Oath, which is for Equity Government using the
Common Law, General Elections that change Governing Majorities, and Corruption Remedy Priorities for
each Parliament Session decided by the Coronation Oath Enforcement Authority.

The 2021 Parliament Session Priority is Remedy Delivery. Session Priority Tests used the cases of Citizen
Mrs Theodorou and other Citizens They got Remedy Denial Fraud Proof against the State, Profession
Authorities, Law Courts Cabinet and Parliament. It enables the Coronation Oath Enforcement to require
Detailed Remedies with a Short Time Limit. It got a Confidence Collapse in Parliament and demands for
Leadership Change. Honest MPs want Corruption Exposure. Corrupt MPs do not. Both are using the Covid
Regulation Breach Party Scandal and are using Dismissal Process against Prime Minister Mr Johnson.

The Protection Fraud Network needed Business Expansion to avoid Total Collapse. They chose Family
Sabotage Frauds + Child Care Frauds to get Big Budgets + Budget Fraud Profits an Expatriation Frauds to
get Money Laundering by Sovereign States. The Business Priming Deal was with the Cypriot State. It
needed either Court Power Increase Legislation Frauds by Cypriot Legislators or Jurisdiction Frauds by
Cypriot Judges. It needed Child Trafficking Profit Shares for Cypriot Legislators or Cypriot Judges. Profit
Share Refusals by the Cypriot State Officers got an Extradition Order Conditions Breach Conspiracy by
State Officers in the UK and Cyprus, and Immunity Frauds for the UK State Officers from the Law Courts.

The Cypriot Law Courts and Cypriot Parliament have a choice. It is Contempt Fraud Remedies and
Contempt Fraud Enforcement. One will get International Acclaim and the other International Censure.
