### Stated Reasons

1. A Personal Profit Plan by Corrupt Officers required Criminal Conspiracies for:
  - 1.1. A Business Deal that got Child Care Fraud Co-operation from Organised Criminal Mr Theodorou for the Corrupt Officers against Citizen Mrs Theodorou and the 6 Theodorou Children in exchange for Divorce Property Frauds for him against her
  - 1.2. An Expatriation Order against 4 Children subject to Cypriot Law Court Supervision
  - 1.3. Condition Compliance needed Empowerment Legislation for the Law Courts or Judicial Frauds by the Cypriot Judges. It needed a Profit Share for the Cypriot Judges or Cypriot Politicians. A Profit Share Refusal by the Cypriot State Officers got an Order Breach Contempt Fraud by the London Borough of Enfield Council and Order Breach Contempt Immunity Frauds by English Top Judges
2. In June 2016 Mrs Theodorou learnt about the Coronation Oath Enforcement Authority. She gave a Privilege Waiver and Confidentiality Waiver and use of her cases and received Case Management Services from Equity Lawyer Mr Ellis. It got Corruption Proof and Remedy Denial Fraud Proof for Citizen Mrs Theodorou and All Guilty Parties. The Coronation Oath Enforcement used it and Similar Fact Fraud Proof got by others to decide the Corruption Remedy Priorities for Parliament Sessions.
3. The 2021 Parliament Session Priorities required Remedy Deliveries. Session Priority Test Cases got Remedy Denial Fraud Proof for the Coronation Oath Enforcement Authority against the State, Profession Authorities, Law Courts, Cabinet, Prime Minister Mr Johnson and Parliament. MPs need a Leadership Change. They dare not disclose the true reason. They are using the Covid Regulation Rule Breach Party Scandal. MPs need Remedy Delivery to avoid a Forced General Election in which they have to explain the Remedy Denial Frauds. The Corruption Proof Sets got by the Theodorou Cases make it the Child Trafficking Lead Chase
