

Royal Commission + Press Release Request Response from Equity Mr Edward Ellis 23rd January 2022

The 2021 Parliament Session Priority is Remedy Delivery. It needed Responsibility Apportionment between Case Remedies by Law Courts and Mass Remedies by Parliament. It needed Remedy Co-operation Tests of the Authorities, Registered Professions and Unregistered Professional.

Test Cases got Remedy Denial Fraud Proof against the State, Profession Authorities, Law Courts, Cabinet and Parliament. Confidence Collapses got Service Refusals, and Protect Fraud Demands that went up the Command Chain of the Protection Fraud Network. Confidence Recovery needed Power Boasts and Fraud Commitment Proof from Prime Minister Mr Johnson. What they got included Media Ministry Powers and Cabinet Officer Rank for MP Ms Dorries, and Knighthood Recommendation Fraud for Former Prime Minister Mr Blair.

The Power Boasts increased the Confidence Collapses. MPs needed a Leadership Change. Honest MPs wanted Corruption Exposure and Remedy Deliveries. The Protection Fraud Network and Corrupt MPs needed Remedy Denial Frauds, Publicity Restraint Frauds and Non – Disclosure Propaganda to deny Fair Reporting by the Mass Media. Advertising Termination Blackmail by Market Fraud Profiteers got Non-Disclosure Propaganda Frauds from Commercial Media. Licence Termination Blackmail by Media Secretary MP Ms Dorries got them from the BBC. It forced Honest MPs to collaborate in use of the Party Scandal for Leadership Change. Meanwhile, a Knighthood Protest Electronic Petition got more than a million supporters

The Remedy Co-operation Test of the Registered Professions and Unregistered Professions got a mixture of Co-operation Denial Proof by the majority, with Co-operation Failure as the only evidence, Co-operation Refusal Proof by a few, with a Refusal Explanation as the evidence, Hesitant Co-operation by very few, with Unusual Case Management as the evidence, and Full Co-operation by a Tiny Minority.

Remedy Co-operation Tests by Citizen Osteopath 2855 Ms Davies got:

1. Conflict Qualification Fraud Conspiracy Proof + Remedy Denial Fraud Proof against the Corrupt Officers, State, Profession Authorities, Law Courts and Parliament. An Evidence Offer to the Police Corruption Judicial Enquiry + Witness Protection Demand got a Protection Refusal by Worcester MP Mr Robin Walker
2. A Co-operation Refusal Explanation given by a Registered Osteopath was that a Corruption Complaint to the MP would get a Disqualification Fraud by the General Osteopathic Council. Their words are not exact. The meaning is.

Citizen Ms Marilyn Hawes conducted Remedy Co-operation Tests of the Media Industry when Propaganda Fraud Blackmail got Mass Publicity for the Party Scandal. Test Case Documents and Royal Commission Emails provided enough information for Interview Questions and Publicity Decisions. Case Documents and Royal Commission Emails supported Audience Interest Questions by Citizen Ms Hawes. They got Press Release Requests from the Media Industry that got the Request Response from the Equity Lawyer. The People will get Full Disclosure. The choice for the Media Industry is to risk Parliament Session Priorities that get Full Disclosure and Propaganda Fraud Penalties or provide Honest Reporting in time to avoid it.
