

Before High Court Justice Moor in Royal Court

on 27th January 2022

Upon Justice Mr Moor having made the Child Case ZW15C00062 Children Expatriation Condition Breach Contempt Finding that is evidenced by the FD20P00642 Contempt Remedy Directions Order dated 4th October 2021 that included an Appeal Permission Refusal against Citizen Claimant Mrs Theodorou

Upon the FD20P00642 Directions Order containing a Hearing Notice for 27th January 2022 and a Case Reservation for Justice Mr Moor.

Upon the FD20P00642 Contempt Remedy Directions Order having got Repeat Order Breach Contempt by the London Borough of Enfield Council

Upon the Contempt Immunity Fraud Appeal 2021 000065 of Citizen Appellant Mrs Theodorou having got an Appeal Permission Refusal and Totally Without Merit Reason.

Upon Citizen Claimant Mrs Theodorou having made Contempt Fraud Conspiracy Allegations that are supported by the Child Case ZW15C00062 Order Conditions Breach and the FD20P00642 Contempt Remedy Directions Order Breach and the Fraud Appeal 2021 000065 Permission Refusal and Totally Without Merit Reason

Upon the circumstances creating a Conflict Jurisdiction Disqualification and Remedy Only Jurisdiction Limit for Citizen Claimant Mrs Theodorou against Enfield Council Case Officers and Justice Mr Moor and All Justices of the High Court and Lord Justices of the High Court and Court of Appeal

Upon Citizen Claimant having given Justice Mr Moor the option of a Court Motion Remedy Order or an Application Remedy Order

1.1. The Child Case ZW15C00062 Final Care Order dated 10th June 2016 included the Recitals:

1.1.1. And upon the local authority agreeing to translate the judgment, this order and the annexes hereto into Greek

1.1.2. And upon the local authority agreeing to fund the registration of the Judgment, this order and the annexes in the Cypriot Court

- 1.1.3. And upon the Cypriot Central Authority having provided consent to the children Marinos, Sophia, Alexandra and Helena being placed in Cyprus pursuant to Article 56 of Brussels IIa
- 1.2. The Child Case ZW15C00062 Final Care Order dated 10th June 2016 included:
 - 1.2.1. An appointment for Sofia Anastasi and Panagiotis Anastasiou as Special Guardian for Marinos Theodorou (29/9.2003) and permission for his permanent removal from the jurisdiction
 - 1.2.2. An appointment for Kyriakou Kyriakou and Stelios Anastasiou as Special Guardian for Sophia Theodorou, Alexandra Theodorou and Helena Theodorou and permission for their permanent removal from the jurisdiction
- 1.3. The Recited Agreements procured and were Binding Conditions of the Final Order for the London Borough of Enfield Council and All Responsible Officers and the Special Guardians
- 1.4. The Document Registration Condition Breach by London Borough of Enfield Council was an Order Breach Contempt that denied Case Supervision by the Cypriot Courts
- 1.5. The Wardship Claim FD20P00642 Order dated 4th October 2021 contains the recital:

‘Upon the court being satisfied that

 - a. the children are habitually resident in Cyprus and
 - b. the court does not retain any jurisdiction in relation to the children’. The order required Child Case ZW15C00062 Order Condition Breach Remedies that included ‘
 - 1.6. The Wardship Claim FD20P00642 Order dated 4th October 2021 included

‘ 6. The Local Authority shall file and serve on the Mother by 4. P.m. on 17th January 2022 a statement setting out the steps it has taken in Cyprus and the outcome of those steps.’
 - 1.7. The Wardship Claim FD20P00642 Case Statement Disclosure Order Breach by the London Borough of Enfield Council was a Repeat Order Breach Contempt and Contempt fraud Conspiracy Proof that gets a Proof Burden Reversal on everything for Citizen Mrs Theodorou and the 6 Theodorou Children. It invalidates everything that got the Child Case ZW15C00062 Final Order and Expatriation Permission and Wardship Claim FD20P00642 Jurisdiction Deficit Recital
 - 1.8. The Sibling + In Law Relations between Special Carer Stelios Anastasiou and the Respondents require a Credibly Independent Child Carer Fitness Investigation
