Royal Commission + 2022 0043 Contempt Fraud Complaint + Remedy Proposals of the Citizen 28th January 2022

Case Substitution Complaint Fraud Complaint

Case Substitution Fraud Criminal Conspiracy by the Ministry of Justice, Barkingside Magistrates Court and Snaresbrook Crown Court.

A Forgery Complaint by the Citizen motivated Housing Association Officers to get Protection Frauds from Top Judges. Everything that could go wrong for them did go wrong. State Officers and Court Officers demanded Protection Frauds from Law Court Judges and used Identity Record Frauds and Case Misrepresentation Frauds. The Case Original Papers and Case Computer Records and Complaint Paper Records and Complaint Computer Records were Forensic Test Material + Record Fraud Material. The Seal Ink on Original Papers was Original Document Proof + Record Fraud Proof. The Electronic Record Inconsistencies between Case Records and Complaint Records was Record Fraud Proof.

The Corruption Remedy Process of the Coronation Oath Enforcement Authority caused a series of Confidence Collapses. Corrupt Officers made Forensic Test Sabotage Fraud Plans. The 1st Plan needed Paper Records Location Knowledge and a Theft Event. In September 2020 the Citizen attended a Case Hearing at Barkingside Magistrates Court with a Big Bag and produced Original Papers. The Corrupt Officers knew he used the Underground Railways and procured a Bag Snatch Theft outside an Underground Station. The Corrupt Officers realised the Electronic Record Inconsistencies were Record Fraud Proof and made a 2nd Plan. It used a Housing Offer to Mrs Nkrumah that got a Tenancy Surrender by her and an Eviction Fraud against Mr Nkrumah. A Lawful Re-entry by Citizen Mr Nkrumah got a Criminal Damage + Assault Charge Fraud by the Metropolitan Police for the Landlord. The Eviction Fraud + Criminal Damage + Goods Theft Complaint by the Citizen got an Investigation Denial Fraud by the Metropolitan Police for the Landlord. The Citizen discovered his Computer + Other Goods in a skip outside the house. A Complaint by the Citizen got an Arrest Fraud + Assault Charge Fraud by the Metropolitan Police and Crown Court Election by the Citizen and Trial Reference 2022 0043 from the Crown Court. Top Judges wanted to avoid Trial Audio Records of Contempt Fraud Conspiracy Defence of the Citizen. They needed Simple Facts that got a New Minor Criminal Charge and a Magistrates Court Case Reference and a Trial Preparation Document with the Minor Case Description and the Citizen's Signature and use of the 2022 0043 Plea Hearing as a Charge Change Hearing and No Notice to the Citizen. He noticed the Case Misdescription and refused to sign. He and 3 Jurisdiction Witness attended for the 2022 0043 Plea Hearing and discovered it was not listed. The Court Officers told him that it was Relisted for Friday 28th January 2022.
