Grounds: Fraudulent Breaches of Natural Justice + Human Rights + Overriding Justice Objective

1. Jurisdiction Trial Validity Declaration + Evidence Discovery and Evidence Production and Enquiry and Issue Conflict Discovery and Pending Adjudication Protection Omissions Invalidity Declaration + Jurisdiction and Liability Case Statement Prematurity Invalidity Declaration and Revocation + Conflict Jurisdiction Disqualification Finding + Justice Perversion Finding + Conspiracy Finding + Fraud Finding + Bias Finding + Contempt Finding + Jurisdiction and Liability Case Statement Filing Directions Revocation for the Citizen against the Crown Prosecutors, State and Crown Court Plea Hearing Judge Canavan for the Stated Reason:
  - 1.1. The Before Case Call Electronic Recording Prohibition Repeat Notice Order from the Judge Canavan to the Court Clerk and Security Manager in the Waiting Area was an Intimidation Fraud against the Citizen Defendant and the Defence Witnesses
  - 1.2. The Court Room Repeat Notices, and use of a Security Guard to make them, were an Intimidation Fraud because the Before Case Call Notices made them excessive
  - 1.3. The use of a Public Gallery Security Guard was an Intimidation Fraud of Citizen Witnesses Mr Sham Sood, Ms Monica Linton and Equity Lawyer Mr Edward Ellis
  - 1.4. The Dock Entry Requirement denied the Citizen use of the Representation Bench and gave a Case Management Advantage to the State a place to keep papers and make notes
  - 1.5. Non – Disclosure Fraud of the Assistance Obligation of the Opposing Representative and Hearing Judge for the Unrepresented Party masked by mention of Qualified Lawyer Representation Rights and McKenzie Friend Advice
  - 1.6. The Public Gallery Seat Requirement for the Equity Lawyer, as Defence Assistant, was a Legal Assistance Sabotage Fraud + Intimidation Fraud
  - 1.7. The Silence Requirement of the Defence Assistant was an Advice Initiative Denial Fraud + Intimidation Fraud
  - 1.8. Guilty and Not Guilty Plea Limit Misrepresentation Fraud denied the No Jurisdiction Plea creates a Jurisdiction Trial Entitlement
  - 1.9. Contempt Remedy Application Draft Order dated 16<sup>th</sup> January 2022 contained Corruption Allegations that imposed a Conflicted Interest Enquiry Obligation on Crown Counsel and Crown Court Judges
  - 1.10. The Read Document Admission is Conflict Enquiry Notice Proof against Judge Canavan
  - 1.11. The Conflict Enquiry Failure Fraud
    - 1.11.1. Denied discovery that a Protection Test Set of 3 Witnesses attended:
      - 1.11.1.1. To give a Privilege Waiver + Confidentiality Waiver + Data Protection Waiver and that deprive Representatives and State Officers of Disclosure Order Breach Defences and enable Rapid Processing of Order Breach Contempt Cases by Law Courts
      - 1.11.1.2. To discover whether it got Witness Protection for them and the others

- 1.11.2. Denied discovery the Benefits Trial Fraud 2018 0394 for the State against Citizen Ms Berry v State created Conflicted Interests against Crown Court Judges including Ms Canavan
- 1.12. Contempt Remedy Application Refusal Fraud using the Reason Fraud + Contempt Definition Misrepresentation Fraud that Contempt Liability had a Court Session Event Limit and there had not been a Court Session Event
- 1.13. A Jurisdiction Trial Order + Case Statement Directions + Trial Date for 6<sup>th</sup> April 2022
- 1.14. Dock Confinement + Advice Harassment Fraud denied the Citizen and Equity Lawyer a Fair Opportunity to get the Evidence Discovery and Evidence Production and Enquiry and Issue Conflict Discovery and Pending Adjudication Protection Directions.
- 1.15. The Pending Adjudication Enforcement Stay Protection Application got an Application Refusal that
- 1.16. Jurisdiction Trial Pending Adjudication Prosecution Stay Denial Fraud that used the Reason Misrepresentation Frauds that
  - 1.16.1. denied the distinction between Prosecution Enforcement and Liability Enforcement
  - 1.16.2. pretended Jurisdiction Deficit Findings get Case Stays and not State Case Dismissals
- 1.17. An Any More Jurisdiction Trial Directions Enquiry by Judge Canavan got a No More Reply from the Citizen because the Equity Lawyer was satisfied the Harassing Behaviour of Judge Canavan was motivated not only for Advice Sabotage but because the Plea Hearing had a 15 Minute Allocation, the Audio Record was Bias Fraud Proof for the Citizen and the Coronation Oath Enforcement Authority
- 1.18. The Crown Prosecution Service Email Address Request got an Email Address Provision Commitment but did not get the Email Address
- 1.19. The Jurisdiction Trial Order created a Pending Adjudication Remedy Only Jurisdiction Limit
- 1.20. The Liability Trial Directions are the Crime Proceeds of a Conflict Qualification Fraud
2. Disclosure Order for the Citizen against Agent Crown Counsel Agent Ms Gemma Rose that within 7 days she files and serves a Statement explaining whether the State Case Instructions were sufficient for her to deal with all issues evidenced by the Bias Contempt Fraud Remedy Application dated 31<sup>st</sup> January 2022 of the Citizen, and if so, why she should not have Joint Liability for the Bias Fraud Contempt
3. All Cases Stay Order Pending Adjudication of the 2022 0043 Jurisdiction Trial and Appeal for Citizen Mr Nkrumah against All State Officers, the Ministry of Justice and All Inferior Law Courts
4. Contempt fraud Investigation Order + Investigator Appointment Case Reference to the Cabinet
5. Contempt Investigation + Jurisdiction Trial Discovery Order + Unredacted Evidence Production Order + Contempt and Terrorism Penalty Warning for the Citizen that the Chief Executive Officer of the Metropolitan Police and the London Borough of Barking and Dagenham Council and the Ministry of Justice do file and service Disclosure Statement and produce All Records of the cases that involve Citizen Mr Akwasi Nkrumah
