Appeal + Claim Brief Case Explanation

Conspiracy to pervert the course of justice by breach of the Protection Justice Obligation owed by the Prime Minister owed to the Claimant and all others, and breach of the Protection Justice Accountability Obligation of the Opposition Leader and provision of Immunity Frauds. The Top Corruption Controls are:

1. The Coronation Oath for Equity Governance using the Common Law
2. Corruption Remedy Priorities for each Parliament Session that are decided by the Coronation oath Enforcement Authority
3. General Elections that change Governing Majorities

The Citizen, Crown and Lord Bishops are the Coronation Oath Enforcement Authority. They are the Profession Authority for Top Judges and Top Politicians. The Citizen has Investigation Jurisdiction. The Crown has Prosecution Jurisdiction. It is the power to issue Trial Orders for Justice Process Contempt Cases against the State and Unfitness Cases against Officers and Authorities. They use the Corruption Remedy Proof Standard. It is Official Records that are Justice Proof for Honourable Officers or Guilt Proof against Corrupt Officers and Credibility Irrelevance Proof for the Victim. The Citizen gets Corruption Proof against the State and Remedy Denial Fraud Proof against the Law Courts. The Official Records are Admissible Evidence for Prosecutions by the Crown and Adjudications by Lord Bishops. The Individual gives a Privilege Waiver and Confidentiality Waiver and Case Use Authority and gets Citizen Status with a Protection Rights from the Crown and Parliament and Protection Enforcement Obligation against the Cabinet and Prime Minister and Protection Accountability Obligation against the Opposition Leader. Politicians vested Dictator Powers in the State and lost control of them to Crime Partnerships of State Officers and Law Court Judges. They developed a Protection Fraud Network to provide Support Services and Corruption Co-ordination. It sells Market Frauds to Organised Crime, provides Protection Frauds for the Corrupt Officer who manage them, and trades Glittering Cares Guarantees and Job Profits for Fraud Services by Corrupt Parliamentarians. The Corruption Remedy Process got Criminal Conspiracy Proof Sets for Dismissal Cases

against Top Judges in Parliament. The Protection Fraud Network made a Business Expansion Plan to avoid Total Collapse and a Corruption Continuity Plan. The Business Expansion Plan was to use Family Sabotage Frauds Children Thefts to get Big Budgets + Budget Fraud Profits and Expatriation Frauds to get Money Laundering Services from Sovereign States. They made a Business Priming Deal with Corrupt Officers of the Cypriot State. It needed Crime Profit Shares for Cypriot Parliamentarians to get Power Increase Legislation for the Cypriot Courts or for Cypriot Judges to get Jurisdiction Frauds. It got a Profit Share Refusal by the Cypriot State Officers. A Business Deal got Corruption Co-operation from Mr Theodorou for the State in the Family Sabotage Frauds + Child Care Frauds against Mrs Theodorou and the 6 Theodorou Children in exchange for Divorce Property Frauds for Mr Theodorou against Mrs Theodorou. The Child Care Case ZW15C00062 used about 70 hearings to get Fraud Knowledge Admissions and Remedy Denial Fraud Commitments from hundreds of State Officers and Law Court Judges. The Final Care Order contained recitals that made the Expatriation Permission conditional upon Case Supervision by the Cypriot Court. It got a Court Involvement Refusal by the Cypriot State Officers and a Condition Breach Contempt Fraud by Corrupt Officers of Enfield Council.

Mrs Theodorou discovered the Coronation Oath Enforcement Authority and the Remedy Process, gave the Privilege and Confidentiality Waivers and Case Use Authority. The Divorce ZC14D02308 Property Case got Fraud Conspiracy Proof against Mr Theodorou, Representatives and the Law Courts. Wardship Claim FD20P00642 got Audio Records and Order Recitals that were Remedy Jurisdiction Denial Frauds and Condition Breach Findings, and Condition Performance Orders and Condition Breach Contempt Immunity Frauds. The 2021 Parliament Session Priority is Remedy Delivery. Cases ZC14D02308 and FD20P00642 are Remedy Denial Fraud Conspiracy Proof against the Law Courts, Cabinet and Prime Minister and Protection Accountability Denial Fraud Proof against the Opposition Leader

Court Frauds got Dismissal Decisions against Top Judges. Dismissal Failures got Unfitness Cases and Dismissal Decisions against Prime Minister Mr Johnson. MPs are using the Party Scandal for the Dismissal Process because they cannot agree to make Full Disclosure to the People
