Stated Reasons

1. Contempt Fraud Appeal CH 2022 000238 Permission Refusal dated 4th February 2022 is Criminal Conspiracy Immunity Fraud Proof for the Citizen Tenant Mr Hastunc and the Coronation Oath Enforcement Authority against the Landlord, Eatsnow Estates Limited and the Directors, Landlord Representatives, Black Graff LLP, Tenant Representatives, Silvine Law, County Court and Chancery Court. The Criminal Conspiracy used:
 - 1.1. Conflict Qualification Frauds by All Relevant Justice Officers
 - 1.1.1. for the Cyprus Gardens Claim F02ED793 Management Frauds and Contempt Remedy Counterclaim Denial Frauds
 - 1.1.2. The Statutory Demand Enforcement Fraud
 - 1.1.3. The Statutory Demand Set Aside Application 2021 45 Management Frauds
 - 1.1.4. The Contempt Fraud Appeal CH 2022 000238 that got a Pending Appeal Adjudication Case 2021 45 Process Stay Protection for the Citizen Tenant against the Landlord
 - 1.1.5. The Statutory Demand Set Aside Application 2021 45 Pending Adjudication Protection Breach Contempt Fraud that got the Alleged Order dated 24th January 2022
 - 1.1.6. The Statutory Demand Set Aside Application 2021 45 Decision Proof Denial Fraud
2. The Top Corruption Controls are the Coronation Oath for Equity Governance using the Common Law, Corruption Remedy Priorities for each Parliament Session decided by the Coronation Oath Enforcement Authority, and General Elections that are stop Power Concentration in Too Few People. The Coronation Oath Enforcement Authority is the Profession Authority of Top Judges and Top Politicians. They use the Corruption Remedy Proof Standard. It is Official Records that are Justice Proof for Honourable Officers or Guilt Proof against Corrupt Officers and Credibility Irrelevance Proof for the Victim.
3. The Individual gives a Privilege Waiver and Confidentiality Waiver and Case Use Authority. It enables Case Management that gets Proof Sets that meet the Corruption Remedy Proof Standard. Citizen gets Corruption Proof against the State and Remedy Denial Fraud Proof against the Law Courts.
4. Many Cases got Corruption Findings and Dismissal Decisions against Law Court Judges and Enforcement Responsibility for Prime Minister Mr Johnson. Enforcement Failures got Dismissal Decisions against him. Record Frauds by the Law Courts creates a need for Audio Records that are Personal Responsibility Proof against Identifiable Individuals. The Reconsideration Hearing will get Justice Mr Roth or someone else, and Fraud Remedy Proof or Remedy Denial Fraud Proof.
