Equity Lawyer Mr Edward William Ellis is one of my friends. On 25<sup>th</sup> October 2018 we had a conversation He told me about the progress made by the Corruption Remedy Process. I am on the address list for Remedy Process Emails. When I am well enough I read them. I have read some and replied to a few of them. When I am not well I do not read them but am pleased to know I am not forgotten. 26<sup>th</sup> October 2018 was my 58<sup>th</sup> Birthday and the 18<sup>th</sup> Anniversary of the Murder of my baby, Sunaina Chaudhari. The Equity Lawyer produced a Will dated that day to service Repeat Co-operation Tests for the Remedy Process. I asked for changes. This is the result.

The Equity Lawyer made a Strategic Decision for the Remedy Process. It needed Criminal Conspiracy Proof against Corruption Controllers for the Judicial Office Unfitness Cases in Parliament. The Strategic Decision was to focus on Drug Crimes, Property Crimes and Child Theft Crimes and not to focus on National Health Service Corruption. It was impossible to achieve a complete separation. The Mental Health Frauds are Case Management Service Frauds by the National Health Service for the Corruption Controllers. They are not Self Defence Frauds by Corruption Controllers in the National Health Service. The Equity Lawyer intended to get completion of the Judicial Office Unfitness Cases and then deal with National Health Corruption.

The Judicial Office Unfitness Case Notices did two things. They put the Unfitness Cases in Parliament. They enabled Protection Fraud Investigations by the Crown, Lord Bishops and Honourable Members in Parliament. Top Judges made Protection fraud Demands. Corrupt MPs made Protection Fraud Promises. Top Judges ignored the Judicial Office Unfitness Cases, used Court Frauds to provide Protection Frauds for State Officers in exchange for Discredit Frauds and Intimidation Frauds against Unfitness Case Witnesses.

I do not know the identity of NHS Patient No: 632 855 6020. I understand the Medical Service Denial Fraud Blackmail against Patient No: 632 855 6020 was Kidney Transplant Treatment Denial Threats to extort Mental Health Examination Consent. It was more than a Mental Health Fraud. It made National Health Service Corruption a Relevant Issue in the Judicial Office Unfitness Cases. I understand the Patient made an Immunity Negotiation Offer got Full Disclosure by the GP that identified Two Consultants and enabled investigation of the Medical Service Denial Fraud Blackmail. I do not know the identity of the GP. I am grateful the GP made Full Disclosure. It helps my case.

I agreed to the use of my cases for the Remedy Process. My parents died. I knew they left assets worth almost £1,000,000. I am entitled to a one quarter share of it. I needed my share. There were Reasonable Suspicions of a Probate Estate Management Sabotage Fraud and Disinheritance Fraud against me. I made the Will dated 13<sup>th</sup> March 2018. I imposed Remedy Co-operation Conditions on gifts to my siblings and former husband. It enabled Remedy Co-operation Tests that got Co-operation Proof for my sister, Ms Neelu Berry and her son, Mr Amrit Berry. I prefer my sister, Mrs Shirmila Sharma, my brother Mr Salil Chaudhari to have another chance to create Remedy Co-operation Proof and qualify for the Will Gifts.

I have a cancer. It was bigger than now. It was so big I could not stand straight. A private supply of drugs has reduced the cancer. I can stand straighter now. I feel strong enough to service the Remedy Process again. I repeat the Will dated 13<sup>th</sup> March 2018 and revoke anything that amended it. I want my siblings and former husband to have another chance to satisfy the Remedy Co-operation Condition. All they have to do is make Full Disclosure to the Equity Lawyer and sign Official Records that meet the Corruption Remedy Proof Standard. Also, on 6<sup>th</sup> June 2018 I survived a Mercy Killing. I am glad that I did. Remedy Process Notices and Protected Witness Notices got reduced opiates and increased oxygen and a Miraculous Recovery. I believe the Next of Kin and Friends should have Mercy Killing Appeal Rights to Lay Juries called by the Coroner. It might help if the Patients are not named but identified by NHS Numbers in the Mercy Killing Appeal Papers.
