1. The Ukraine Invasion by Russia has got Special Relevance of the Court Frauds against Citizen Mr Zarb. Efficient Explanation needs Link Brief Histories

The Dictator Governance Plan + Endemic Corruption Brief History

2. Politicians made a Governance Fraud Plan to vest Dictator Power in the States of Western Europe. It substituted the Obedience Priority of the State for the Justice Priority of the People. A Corruption Control Freeze enabled Obedience Enforcement. The Inevitable Result was Endemic Corruption managed by Crime Partnerships of State Officers and Law Court Judges, and controlled by Protection Fraud Networks. They substituted the Predation Priority of Organised Crime for the Obedience Priority of the State and Justice Priority of the People.

The Fraud Management Careers Brief History

3. The 13 years, from 1997 to 2010, got Computer System Budget Frauds that finance Top Level Corruption for the Labour Governing Majority. They were Batch Frauds that used Time Records for one contract for all Batch Contracts. The Recruiting Priority was the identification and elimination of anyone who was a Whistle Blower Risk. They started with Execution Contracts with Design Requirement



Specifications that had Obvious Design Flaws. They wanted Employment Applicants who noticed the Design Flaw, established the State had Flaw Liability and committed enthusiastically to Revenue Opportunity of the Execution Contract. The Employment Interview got Design Criticisms, Remedy Proposals and Anxious Behaviour from Mr Zarb. It got a Fraud Report Bad Risk Finding because of a Moral Satisfaction Motive and Low Stress Threshold Self-Defence Motive. They put him on the State Contract Black List. It denied him any chance to service State Contracts. A similar experience with Reuters denied him Global Corporate Business.

4. Some of the Fraud Managers made Career Decisions for Sanctions Busting and Opportunistic Decisions for Covid Equipment Budget Frauds under Prime Minister Mr Johnson.

The Sanctions Busting Brief History

5. International Outrages got Economic Sanctions and Sanctions Busting Business for the Protection Fraud Network The Ukraine Invasion Plan used Sanction Busting Frauds by the Protection Fraud Network to buy NATO Defence Assets and create Corruption Conflicted Interests to undermine NATO Defences. The Ukraine Invasion has created an opportunity for Crime Proceeds Forfeitures against Budget Fraud Profiteers, Protection Fraud Profiteers and Sanction Busting Assets. Rapid Progress needs Immunity Deals with Fraud Managers to get the Crime Proceeds Evidence that is Asset Forfeiture Evidence.

The Coronation Oath Enforcement Authority and Corruption Remedy Process

6. The Dictator Governance Plan used Law Profession Governance Frauds to deny the Coronation Oath Enforcement Authority a Reliable Supply of Admissible Evidence needed for Parliament Session Decisions. It got a Dormancy Period that lasted 45 years. In 2004 Corruption Proof against European Leaders enabled a Corruption Notice to the Crown and Parliament. It ended the Dormancy period and revived use of the Coronation Oath Enforcement Authority. It got a Corruption Remedy Process that has continued ever since.
7. The 2015 Parliament Session Priority was Corruption Dismissals against Top Judges. The preparations took a year. In 2016 the European Referenda Leave Majority got an Honourable Resignation of Prime Minister Mr Cameron got a Leadership Contest. The Protection Fraud Network needed to stop the Top Judge Dismissals. They bought Support Votes for MP Mrs May because she was one of them. She demanded New Fraud Commitment Proof. The Budget Fraud Managers chose Citizen Mr Zarb as one of their New Fraud Targets. The Remedy Process broke the confidence of Law Court Judges for Rapid Completion. In 2019 Corruption Proof got a Forced Resignation from Prime Minister Mrs May, a Leadership Contest and a Protection Fraud Deal with Prime Minister Mr Johnson. The Remedy Process got Corruption Proof, Remedy Denial Fraud Proof, an Unfitness Finding and Dismissal Decision against him. The Protection Fraud Network used Revenue Termination Blackmail to get Dismissal Decision Non-Disclosure Propaganda Frauds by the BBC and Commercial Media. It got the Covid Regulation Breach Party Scandal. Audio Records became Career Liabilities for Top Judges. The Ukraine Invasion got Asset Status for Protection Fraud Exposure with Dithering + Squabbling by Politicians + Journalists.
