Grounds: Fraudulent Breaches of Natural Justice + Human Rights + Overriding Justice Objective

Representations

The Mortgage Possession Claim H1PP8822 Court Records are Protection Fraud Proof against Prime Ministers Mr Blair, Mr Brown, Mrs May and Mr Johnson. They made Protection Fraud Deals with the Pharmaceutical Industry and then the Indian Federation. They needed a Destruction Consent of the Body Remains of Baby Sunaina Chaudhari and then a Death Inquest Claim Withdrawal in the Indian High Court. The Genome Project created a High-Priced Market for Human Organs that were Genetic Defect Evidence. Killer Doctors used Foetal Scans that showed Development Defects for Genetic Defect Diagnosis Frauds and Abortion Frauds, Full Anaesthetic Caesarean Section Births Frauds and Hospital Murders to get Human Organ Sale Profits. In 2000 the Sunaina Chaudhari Case exposed it. The Hospital Records were Murder Proof. The Official Records were Murder Protection Fraud Proof against All Authorities with Accountability Powers. The Chaudhari Family kept the Body Remains in the hope of justice. The Coronation Oath Enforcement Authority managed a Corruption Remedy Process.

In 2006 it got a Forced 10 Months Retirement Notice from Prime Minister Mr Blair. He spent the Notice Period making Protection Fraud Arrangements that he thought would last his lifetime. One of them was a Destruction Order of the Body Remains of Sunaina Chaudhari. The Chaudhari Family took the Body Remains to India and made a Death Inquest Application in the Indian High Court. It got a Valid Case Finding, Body Remains Preservation Order and Out Of State Death Inquest Jurisdiction Deficit Reference from the High Court, to the Supreme Court, Law Commission and Parliament. Protection Fraud Deals got Death Inquest Delays for the Pharmaceutical Industry and Massive Investments for the Indian Pharmaceutical Industry.

In 2018 Mrs Chaudhari had Terminal Cancer. She gave a Privilege Waiver, Confidentiality Waiver and Case Use Authority to the Coronation Oath Enforcement Authority. She made a Will with an Executor Appointment Equity Lawyer Mr Ellis and Will Gifts to her 3 Siblings and Former Husband on Corruption Remedy Conditions that required Full Disclosure from them. It got Full Disclosure by Mrs Neelu Berry and Disclosure Refusals by the others. She gave them a second chance. A Repeat Will got Repeat Disclosure Refusals by the others.

Prime Ministers Mrs May and Mr Johnson used H16X00733 and 2020 000286 to get General Civil Restraint against Equity Lawyer Mr Ellis in 2018 and a Restraint Renewal in 2020 that stopped him from obtaining a Probate Grant. Claim CO 612 2022 is for a Restraint Renewal. The H1PP8822 Fraud Appeal and the CO 612 2022 will force the County Court and Administrative Court to process the Possession Fraud Proof.
