Sadhana Chaudhari alias Dolly Chaudhari alias Sadhana Dolly Chaudhari lived at 450 New North Road, Hainault, Ilford IG6 3EB. In 2000 she gave birth of her only child, Sunaina Chaudhari who was the victim of a Hospital Murder and Human Organ Theft. The Genome Project created a high Value Market for Human organs that were Genetic Defect Evidence. Killer Doctors used Foetal Scans that were Development Defect Evidence for Diagnosis Frauds + Prescription frauds to get Abortion Frauds + Abortion Material Possession + Sale Profits and Caesarean Section Birth Full Anaesthesia Frauds + Unconscious Periods for Baby Murders that enabled Human Organ Thefts + Sale Profits. The Sunaina Chaudhari Case exposed it. A Business Deal got 2001 General Election Campaign Finance for Prime Minister Mr Blair in exchange for Protection frauds for the Pharmaceutical Industry. The Medical Records are Murder Proof. The State Records and Court Records are Murder Protection Fraud Proof against All Authorities that have Accountability Powers. The Chaudhari Family kept the Body Remains in Redbridge Morgue in the hope of justice.

In 2004 the preparations for the European Referenda got Election Fraud Conspiracy Proof against European Leaders including Prime Minister Mr Blair. It got revived use of the Coronation Oath Enforcement Authority after a Dormancy Period of 45 years. It got a Corruption Remedy Process. In 2006 the Remedy Process got a Forced 10 Months Retirement Notice from Prime Minister Mr Blair. He used the Notice Period to make Protection fraud Arrangements that he hoped would last his lifetime. He issued a Body Remains Destruction Order. The Chaudhari Family took the Body Remains to Delhi. A death Inquest Application by the Mother got a Valid Application Finding + Body Presentation Order + Out of State Death Inquest Jurisdiction Deficit Finding + Jurisdiction Deficit Case Remedy Reference to the Supreme Court + Law Commission and Parliament. It got Out of State Death Inquest Jurisdiction for the Indian Law Courts. A Protection Fraud Deal got Death Inquest Denial Frauds for the Pharmaceutical Industry in exchange for Massive Investments in the Indian Pharmaceutical Industry. It needed Death Inquest Delay Frauds until the Mother died and then a Body

Remains Destruction Consent + Death Inquest Claim Withdrawal by her Probate Estate Personal  
Representatives. The Mother knew this. She and Equity Lawyer Mr Ellis made a Protection Fraud Sabotage  
Plan. It needed either a Probate Grant for Equity Lawyer Mr Ellis or Probate Grant Denial Fraud Proof  
against Prime Ministers and Cabinets. It used a Will dated 13<sup>th</sup> March 2018 that made an Executor  
Appointment of the Equity Lawyer and Will Gifts to the 3 Siblings and Former Husband on Remedy Co-  
operation Conditions that required Full Disclosure. It got Remedy Co-operation from Mrs Neelu Berry and  
Remedy Co-operation Refusals by the others. She made a Repeat Will dated 10<sup>th</sup> November 2018 that  
acknowledged the Remedy Co-operation + Gift Qualification of Mrs Berry and the Remedy Co-operation  
Refusals by the others and gave them another chance. It got Repeat Remedy Co-operation Refusal Proof  
against them. The Mother died on 6<sup>th</sup> December 2018.

General Civil Restraint Frauds and Restraint Renewal Frauds by Prime Ministers Mrs May and Mr Johnson  
and their Cabinets were Probate Grant Denial Frauds against the Sadhana Chaudhari Probate Estate. The  
Administration Process gave Due Notice to All Interested Parties. The probate Estate included the Registered  
Freehold Title to 450 New North Road subject to a Mortgage held by the Bank of Scotland. The case facts  
made it necessary to use a Will Notice + Settlement Negotiation Offer by the Equity Lawyer + Mortgage  
Purchase Offer by Mr Amrit Berry to preserve the Priority Rights and Security Rights Pending the Probate  
Grant. Service of them got Settlement Negotiation Refusal Contempt Fraud Proof against the Bank of  
Scotland.

The 2021 Parliament Session is Remedy Delivery. Citizens used their cases for Session Priority Tests got  
Corruption Proof and Remedy Denial Fraud Proof against the Case Parties, State, Profession Authorities,  
Law Courts, Cabinet and Parliament. The Top Judge Dismissal Failures by the Cabinet got Dismissal  
Decisions against Prime Minister Mr Johnson. Corrupt Parliamentarians needed True Dismissal Reason  
Concealment Frauds. They used the Covid Regulation Breach Party Scandal.

The Settlement Negotiation Refusal invalidated filing and issue of the Mortgage Possession Claim  
H1PP8822. The Bank of Scotland used Will No-Disclosure Frauds + Executor Appointment Non-Disclosure  
Frauds + Representation Unfitness Evidence Exclusion Frauds to get a Probate Estate Representative  
Appointment Fraud of Mrs Neelu Berry and Representative Appointment Denial Fraud against the Equity  
Lawyer. Help Request by her got the H1PP8822. Explanation Statement + Draft Order of the Equity Lawyer,  
the Hearing Appearance by him on 2<sup>nd</sup> February 2022, the Defence and Counterclaim and Hearing Proposals  
dated 25<sup>th</sup> February 2022 by him and the Hearing Appearance on 14<sup>th</sup> March 2022. They got Fraud  
Conspiracy Proof against the Bank of Scotland and the County Court. All of it is Relevant Evidence for the  
Restraint Renewal Claim Fraud CO 2022 612 Probate Estate Protection Application and Witness Protection  
Applications of the Equity Lawyer against the Bank of Scotland, Probate Contestants, Ministries of State,  
Solicitor General, Attorney General, Cabinet and Prime Minister.
