Formal Acknowledgement that I have the good luck to be younger than my Older Siblings and older than my Younger Siblings. I have been old enough to understand what has happened to all of us but young enough not to have Responsibility Guilt. Father used Influence Frauds against the Oldest Child, Georgio, to get Influence Frauds by him against the other 5 Children for Family Sabotage Frauds against Mother and the 6 Children. Soon afterwards we realised we had done wrong. We were powerless to undo the damage. I believe Leadership Guilt has compromised the ability of Georgio to make the best of his Relationship Management Skills and Education Opportunities. I believe the 2<sup>nd</sup> Child, Marinos, did not suffer Leadership Guilt, but made a Rational Priority Decision for Self-Respect that compromised his ability to make the best of his Education Opportunities. I know that the 3<sup>rd</sup> Child, Sophia, has the Extreme Vulnerability of Spinal Scoliosis. The Child Care Frauds included the substitution of the Totally Inadequate Services of Limassol Hospital for the World Leading Services of the Specialist London Hospitals. I believe she does not suffer Leadership Guilt but the Extreme Vulnerability compromised her ability to make Relationship Adjustments from Dependent Child to Adult Friend of my Mother. I hope the Remedy Process will make Rapid Progress that helps all of us make the best of the future.
