Upon a Settlement Negotiation Offer for the Claimant not getting Remedy Agreements from the Defendants

Upon the Citizens having used their cases to get Proof Sets that met the Corruption Remedy Proof Standard and were therefore Admissible Evidence that the Coronation Oath Enforcement Authority used to decide the Corruption Remedy Conditions for Parliament Sessions

Upon the 2021 Parliament Session Priority being Remedy Delivery

Upon Citizens having used their cases for Parliament Session Priority Tests that got Corruption Proof and Remedy Denial Fraud Proof against the State, Profession Authorities, Law Courts Cabinet and Parliament

Upon the Political Party Leaders having made a Political Neutral Issue Agreement for the 2022 Local Elections that got Corruption Admissions and Remedy Publicity with BBC News Coverage of Child Care Profit Frauds and Police Officer Appointment Frauds for Convicted Criminals and Immunity Frauds for Child Prostitution Managers

Upon the Political Neutral Issue Agreement having failed to get Interim Remedies for Corruption Victims

Upon the Coronation Oath Enforcement Authority needing Citizens to conduct Representation Tests using Childhood Sabotage Fraud Remedy Claims and Election Fairness Claims

Upon the Child Protection Case ZW15C00062 of the 6 Theodorou Children having got an Expatriation Agreement dated 8th June 2016 between the Social Services of Enfield Council and Cyprus are Expressly Not Legally Binding and a Wish List omits any mention of Jurisdiction Acceptance by Cypriot Courts. The Final Child Care Order dated 10th June 2016 included Expatriation Permits that were conditional upon Jurisdiction Acceptance by the Cypriot Law Courts. The two documents are Condition Breach Contempt Fraud Conspiracy Proof against Enfield Council. From September 2022 to date the Wardship Claim FD20P00642 got Condition Breach Immunity Fraud Proof against the High Court.
