1. Election Fairness Commitments by All MPs and Media Managers for the People
2. Election Fairness Management Rights for Citizen and People using
 - 2.1. Formal Acknowledgement by All MPs they have Remedy Jurisdiction for the Citizen and Political Representation Jurisdiction for the Constituent with Superiority Acknowledgement of Remedy Jurisdiction against Representation Jurisdiction
 - 2.2. Formal Acknowledgement of the Fundamental Laws that
 - 2.2.1. A Validity Investigation has Absolute Priority in every case of Office Fitness and Power Use
