

Royal Commission + Bankruptcy Petition Response of Citizen Mr Hastunc 14<sup>th</sup> May 2022

1. Tenant Mr Hastunc did not know the Landlord Officers are Money Launderers. They used Cypress Gardens Lease Documents and Misrepresentation Frauds to get him to invest £357,000 + Time + Talent converting a Derelict Site into a Profitable Restaurant Business. Then, Lease Denial Frauds + Violent Intimidation Frauds by Professional Thugs did not get a Voluntary Surrender. They bought Law Court Possession Frauds from the Protection Fraud Network and got issue of Cypress Gardens Lease Possession Claim F02ED793. It was unlucky timing for them, the Protection Fraud Network, Cabinet, Prime Minister, Opposition Leaders, House of Commons Speaker and NATO Alliance Saboteurs.
2. In 2019 the Protection Fraud Network needed Emergency Powers. They wanted a Middle Eastern War. An Oil Tanker Seizure by the UK and a Missile Strike by Iran got a War Engagement Refusal by President Trump. They used UK Organised Crime to provide Missile Finance for Turkish Terrorists. President Trump issued the Emergency Evacuation from Syria to avoid US Casualties from British Financed Missiles and a NATO Alliance Collapse. The use of Missile Finance Proof needed Witness Protection from the Law Courts. Case Management by Equity Lawyer Mr Ellis got Criminal Conspiracy Proof against the Landlord Officers, Representatives and Law Courts, and Protection Fraud Proof against the Cabinet, Prime Minister, Opposition Leaders and House of Commons Speaker.
3. The Top Corruption Controls are the Coronation Oath for Equity Governance using the Common Law, Corruption Remedy Priorities for each Parliament Session decided by the Coronation Oath Enforcement Authority and General Elections that change Governing Majorities and stop Power Concentration in Small Minorities.
4. In 2004 the preparations for the European Referenda got Election Fraud Conspiracy Proof against European Leaders including Prime Minister Mr Blair. The Equity Lawyer used it for a Corruption Notice to the Crown and Parliament. It got revived use of the Coronation Oath Enforcement Authority after a Dormancy Period of 45 years and a Corruption Remedy Process that has continued ever since.
5. The 2015 Session Priority was a Fraud Invalidity Precedent, Conflict Disqualification Precedent and Automatic Issue Rights for the Citizen against Law Courts. Citizens issued Corruption Cases that forced Corrupt Officers to choose between making Conflict Disqualification Admissions and committing Conflict Qualification Frauds to get the case Control needed for Issue Denial Frauds + Case Dismissal Frauds + Restraint Frauds against the Citizens. The Set Up Time for Dismissal cases against Top Judges was 1 Year. The European Referenda Commitment in the 2015 General Election got a Governing Majority for Prime Minister Mr Cameron. He used the Set Up Time to hold the European Referenda because he thought the Corruption Exposure of the Dismissal Cases would increase the Leave Vote. He led the Remain Campaign, lost and resigned. It was an Honourable Resignation. The Protection fraud Network needed to stop the Top Judge Dismissals. They bought Leadership Support Votes for MP Mrs May because she was one of them.
6. In 2017 Case Management by the Equity Lawyer got Criminal Conspiracy Proof against Top State Officers and Law Court Judges. The Coronation Oath Enforcement Authority used it to decide the 2017

Session Priority. It was a Long Session of 2 ½ years for Corruption Investigations in the Law Courts to get a New Set of Fraud Proof for Dismissal Cases against Top Judges and use of them for Protection Fraud Investigations in Parliament. Prime Minister Mrs May called a Surprise General Election to avoid a Parliament Session Refusal and Forced General Election with Mass Publicity for the Corruption Proof and Remedy Denial Fraud Proof. It got Corruption Proof against the State and Profession Authorities, Remedy Denial Fraud Proof against the Law Courts and Protection Fraud Proof against the Governing Majority, Cabinet, Prime Minister and Opposition Leader.

7. The 2019 Session Priority was a Forced Resignation from Prime Minister Mrs May and a Forced General Election against the Governing Majority. The Protection Fraud Network wanted Emergency Powers. The War Provocation Efforts failed. The Covid Pandemic got them until February 2022.
8. The Cypress Gardens Lease Possession Claim F02ED793 got a Privilege Waiver, Confidentiality Waiver and Case Use Authority from the Tenant got Citizen Status with Crown Protection and Parliament Protection and Protection Enforcement by the Cabinet and Prime Minister and Protection Enforcement Accountability by the Opposition Leader. The Citizen got Case Management by Equity Lawyer Mr Ellis.
9. Case Management by the Equity Lawyer got Fraud Conspiracy Proof for the Citizen against the Landlord, Landlord Representatives and County Court. Defence Instructions to Qualified Lawyers added Defence Sabotage Fraud Proof against the Defence Lawyers. The Case Papers explain the details. The F02ED793 Frauds invalidated the Statutory Demand.
10. In 2020 the Statutory Demand Fraud got a Set Aside Application by the Citizen and Issue Denial Fraud Proof that added to the Fraud Conspiracy Proof against the Landlord and against County Court.
11. In 2021 the Statutory Demand Set Aside Application got Case Reference 2021 45 added Process Fraud Proof that to the Fraud Conspiracy Proof against the Landlord and the County Court. The Contempt Fraud Remedy Claim 2021 000238 added Process Fraud Proof against the High Court.
12. The 2021 Session Priority was Remedy Delivery. Test Cases got Remedy Denial Fraud Proof against the Law Courts and Protection Fraud Proof against the Cabinet, Prime Minister and Opposition Leader. It includes the Possession frauds that got Crime Proceeds Status and Laundered Money Status for the Cypress Gardens Sale Price. The Bankruptcy Petition BR 2022 000105 is the Crime Proceeds of the F02ED793 Frauds and Statutory Demand Frauds.
