

Royal Commission + 2021 45 Set Aside Dismissal Fraud Appeal Grounds + Proposals 22nd May 2020

Contempt Fraud Appeal against the Statutory Demand Set Aside Application 2021 454 Hearing Notice

Denial Fraud + Secret Hearing Fraud + In Absence Trial Fraud + Dismissal Fraud dated 24th January 2022
of District Judge Wilkinson + Eatsnow Estates Limited + Representative

Grounds: Fraudulent Breaches of Natural Justice + Human Rights + Overriding Justice Objective

Remedy Proposals

1. Validity Priority Finding for the Corruption Case of the Citizen against All Cases of All Others for the Stated Reason that it is Fundamental Law that was restated in the Universal Precedent known as 2008 Houses of Lords R v Clarke
2. Corruption Case Finding for Citizen Mr Hastunc against Eatnow Estates Limited for the Stated Reason that
 - 2.1. The Coronation Oath Enforcement Authority managed a Corruption Remedy process. It needed to achieve Total Destruction of the Protection Fraud Network. It sold Market Frauds to Organised Crime, provided Protection Frauds for Corrupt Officers who managed them and traded Glittering Career Guarantees and Job Profits in exchange for Fraud Services by Corrupt Parliamentarians.
 - 2.2. In 2019 the Coronation Oath Enforcement Authority the Parliament Session Remedy Priorities were a Forced Resignation from Prime Minister Mrs May and a Forced General Election against the Governing Majority.
 - 2.3. The Protection Fraud Network wanted Emergency Powers to defend themselves. They wanted a Middle Easter War to get them. An Oil Tanker Seizure by the UK and Missile Strike by Iran by President Trump. Then, an Emergency Evacuation Order from President Trump moved US Troops out of Syria to prevent US Casualties from Terrorist Missiles financed by Drug Dealers and Money Launderers who had Protection Frauds from UK Authorities. Protection Frauds for Organised Criminals and Corrupt Officers prevented Protection Justice for Witnesses. It created a need for Protection Fraud Proof for the Coronation Oath Enforcement Authority against Organised Criminals.
 - 2.4. The December 2019 Parliament Session Priority was Remedy Proof for the Law Courts or Criminal Conspiracy Proof for Dismissal Cases against Law Court Judges.
 - 2.5. The Cypress Gardens Lease Possession Claim F02ED793 Defence Case of Tenant Mr Hastunc was a Protection Fraud Test Opportunity against Landlords Eatsnow Estates Limited and Law Courts.
 - 2.6. The F02ED793 Defence got Fraud Conspiracy Proof against the Landlord, Qualified Lawyers and the Law Court at every stage of the process, and Protection Fraud Proof against the Cabinet, Prime Minister Mr Johnson and Opposition Leader Sir Keir Starmer.

4. Pending Adjudication Enforcement Stay Order for Citizen Mr Hastunc against Eatsnow Estates Limited
