

BR 2022 000105 Bank Holiday Hearing Confirmation Request + Wasted Costs Warning 22nd May 2020

Formal Demand for a Bank Holiday Monday Hearing Confirmation. Telephone Enquiries on Thursday 26th May 2022 by Equity Lawyer Mr Ellis to 0207947 6733 got No Response + 0207947 6297 Chancery Listings got Mark. He confirmed Monday was a Bank Holiday but did not confirm or deny that there were Bank Holiday Hearings. He gave the Bankruptcy Court Number 02077947 6294. A call to it got No Response.

Bank Holiday Monday Hearing Attendance Wasted Costs Warning from Equity Lawyer Mr Ellis for Citizen Mr Hastunc for the Stated Reasons that:

1. The Corruption Remedy Process of the Coronation Oath Enforcement Authority needed to achieve Total Destruction of the Protection Fraud Network. It sells Market Frauds to organised Crime, provides Protection Frauds for the Corrupt Officers who manage them, and trade Glittering Career Guarantees and Job Profits in exchange for Fraud Services by Corrupt Parliamentarians.
2. The Corruption Remedy Process had Investigation Services provided by Equity Lawyer Mr Ellis.
3. The Investigation Services included Immunity Negotiation Offers to Organised Criminals in exchange for Remedy Co-operation with Full Disclosure about the business of the Protection Fraud Network
4. In 2019 the Remedy Process got a Forced Resignation from Prime Minister Mrs May and a Forced General Election against the Governing Majority. The Protection Fraud Network wanted Emergency Powers. The War Provocation Efforts of an Oil Tanker Seizure by the UK and a Missile Strike by Iran got a War Engagement Refusal by President Trump. Drug Profits with Protection Frauds from UK Authorities provided Terrorist Missile Finance. US Casualties from British Financed Missiles was a NATO Collapse Risk that got an Emergency Evacuation Order from Syria that President Trump could not explain.
5. The Missile Finance and NATO Collapse Risk raised Credibility Doubts about the Protection Fraud Network. Drug Dealers and Money Launderers considered trading Witness Protection + Immunity Terms for Full Disclosure that included identification of Massive Reserves. It needed Safe Conditions for Witness Protection. Drug Dealers and Money Launderers continued to service Routine Business and waited for the Safe Conditions. Honourable Politicians needed Asset Forfeitures against Organised Crime for National Debt Repayments and Corruption Damage Payments.
6. The December 2019 Parliament Session Priority was Remedy Proof for the Law Courts or Criminal Conspiracy Proof for Dismissal Cases against Law Court Judges. The Landlord got issue of Cyprus Gardens Lease Possession Claim Fraud Lease F02ED793. Tenant Mr Hastunc gave a Confidentiality Waiver, Privilege Waiver and Case Use Authority. It enabled Case Management of the Lease Possession Claim Fraud + Statutory Demand Set Aside Case 2020 [No Case Number] + 2021 45 + Statutory Demand Set Aside Application Directions Fraud Appeal 2021 000238 and Bankruptcy Petition BR 2022 000105. They got Fraud Conspiracy Proof for the Coronation Oath Enforcement Authority against the Landlord, Representatives, Law Courts, Cabinet, Prime Minister and Opposition Leaders
7. The Remedy Process needed Audio records as Personal Responsibility Proof against Identifiable Individuals. Top Judges used Hearing Orders and Case Allocations to sacrifice Lower Rank Judges. It creates Reasonable Suspicions the Bank Holiday Hearing is an effort to avoid a Hearing Audio Record.
