Grounds: Fraudulent Breaches of Natural Justice + Human Rights + Overriding Justice Objective

Aggravating Factors:

1. The Case Management Incapacity Finding + Representation Permit for Equity Lawyer Mr. Ellis is Incapacity Finding Failure Proof + Incapacity Remedy Denial Fraud Proof against All Previous Adjudicators
2. The Representation Permit got an Efficient Explanation by the Equity Lawyer that:
 - 2.1. The December 2019 Parliament Session Priority was Remedy Proof for the Law Courts or Criminal Conspiracy Proof for Dismissal Cases against Top Judges in Parliament. All Test Cases got Criminal Conspiracy Proof.
 - 2.2. The 2021 Parliament Session was Remedy Delivery. The Test Cases got Protection Fraud Proof against the Cabinet, Prime Minister and Opposition Leader Sir Keir Starmer
 - 2.3. The 2022 Parliament Session Priority is Remedy delivery. Record Frauds by the Law Courts created a need for Audio Records as Personal Responsibility Proof against Identifiable Individuals for Known Court Frauds.
 - 2.4. Top Judges used Issue Denial Frauds + Hearing Denial Frauds to avoid Audio Record proof against themselves and used Hearing Orders and Case Allocations
 - 2.5. On 23rd May 2022 Test Case Hearings got Audio Records
 - 2.6. On 30th May 2022 Bankruptcy Petition BR 2022 000105 Hearing is the Money Laundering Test Case
3. Interruption Frauds by Judge Mr. Prentis were Representation Sabotage Frauds that prevented a more complete explanation.

Remedy Proposals

1. Valid Priority Finding for the Corruption Case of the Citizen Mr. Hastunc against All Cases of All others in general and, without prejudice to the generality, against the Bankruptcy Enforcement Case of Eatsnow Estates Limited in particular
2. Corruption Case Finding for Citizen Mr. Hastunc against Eatsnow Estates Limited for the Stated Reason it for a Lease Possession Fraud Criminal Conspiracy between Eatsnow Estates Limited, Representatives and the Law Courts
3. Conflicted Interest Finding + Conflict Disqualification Finding + Remedy Only Jurisdiction Limit Finding + Conflict Qualification Fraud Finding + Remedy Only Jurisdiction Limit Breach Finding + Bias Fraud Finding + Contempt Finding + Contempt Remedy Entitlement Finding + Remedy Priority Finding + Bankruptcy Order Revocation + Bankruptcy Costs Revocation + Contempt Liability Order + Cyprus Gardens Lease Possession Order and Costs Order Revocations + Cypress Gardens Lease Possession Return Order + Cypress Gardens Lease Possession Defense and Contempt Counterclaim Costs and Indemnity Standard Assessment Order + Statutory Demand Set Aside Application Dismissal Order Revocation + Special and General and Aggravated and Exemplary Damages Award + £100,000 Interim Damage Award + Contempt Liability Costs and Indemnity Standard Assessment Order
