Stated Reasons

The Top Corruption Controls are the Coronation Oath for Equity Governance using the Common Law, the Corruption Remedy Conditions for each Parliament Session decided by the Coronation Oath Enforcement Authority and General Elections that change Governing Majorities and prevent Power Concentration in Small Minorities. The 2007 Corruption Remedy Conditions required the Universal Precedent that a Validity Investigations has priority in every case that was set by the 2008 House of Lords Case R v Clarke. The 2015 Corruption Remedy Conditions required the Fraud Invalidity Universal Precedents that fraud invalidates all, set by Harland v Harland, and Conflict Disqualification Universal Precedent that a Conflicted Interest is a Conflict Adjudication Disqualification. Conflict Qualification Fraud Claims create Conflict Disqualifications against the Judiciary and vest Neutral Adjudication Qualifications in Lay Jurors. The Claim Directions and Compliance Failure Claim Dismissal by the District Judge and the Directions Appeal Dismissal and the Dismissal Appeal Dismissal by the Circuit Judge are the Crime Proceeds of a Conflict Qualification Fraud. Fraud Proof of anything gets a Proof Burden Reversal for the Victim against the Fraud Manager and the Fraud Beneficiary subject to Rebuttal Proof. In the case of Repeat Court Frauds, it is an Impossible Rebuttal Proof Burden.
